## **APPENDIX I**

To qualify for the extra €20,000 top-up for the Derelict Top-up grant, an independent report from an engineer or a quantity surveyor is required. The Report should contain detailed information regarding the true condition of a property according to the checklist below. Alternatively, the derelict property must be on the Derelict Sites Register.

#### **ELECTRICAL**

- Electrical Fuse board, Sockets and Wiring
- Electrical Bonding of Kitchen Sink and
