**VESTING ORDER P 2024/001**

**WHEREAS** the land described in the Schedule hereto and shown on the map attached hereto, which said map has been marked Longford County Council Compulsory Purchase Order (No. 1) 2022 (No. 7 O'Connell Terrace, Saint Michael's Road, Longford, Co. Longford), and sealed with the seal of the Longford County Council (hereinafter referred to as "the Local Authority") is land to which the Longford County Council Compulsory Purchase Order (No. 1) 2022 (No. 7 O'Connell Terrace, Saint Michael's Road, Longford, Co. Longford) relates, and the said order has become operative in so far as it relates to the said land:

**AND WHEREAS** the local authority have, at least six months prior to the date of this order, entered on and taken possession of the said land in accordance with the powers conferred upon them by section 80 of the Housing Act, 1966, as applied by section 10 of the Local Government (No. 2) Act, 1960 (as substituted by section 86 of the Housing Act, 1966 )

**AND WHEREAS**

- (a) The several interests in the said land have not been conveyed or transferred to the Local Authority,
- (b) The Local Authority consider that it is urgently necessary, in connection with the purposes for which they have been authorised to acquire the land compulsorily, that the acquisition of the land should be completed, and
- (c) The Local Authority have made a proper offer in writing to each person having an interest in the said land who has furnished sufficient particulars of his interest to enable to make a proper offer for such interest:

**NOW THEREFORE** Longford County Council in exercise of the powers conferred upon them by section 81 of the Housing Act, 1966 , as applied by section 10 of the Local Government (No. 2) Act, 1960 , as substituted as aforesaid, hereby order that the said land shall, on the 1st day of May 2024, VEST in the local authority in fee simple free from encumbrances and all estates, rights, titles and interests of whatsoever kind (other than any public right of way).

All that land comprising lands in the Townland of Townparks, Parish of Templemichael, Barony of Ardagh, electoral division of Longford No. 1 and County of Longford being part of the lands on Folio LD362L of the Register of Freeholders County Longford being land particularly delineated and outlined in red and shaded grey on map referenced Longford County Council Compulsory Purchase Order (No. 1) 2022 (No. 7 O'Connell Terrace, Saint Michael's Road, Longford, County Longford), Vesting Order P 2024/001 map, and included as plot numbered OCT007 measuring in total 0.0292 Hectares metric measure.
