The Chair thanked members for agreeing to hold a short special meeting to review and approve funding applications to be submitted to the Community Safety innovation Fund, and to be update on the progress of action development for the community Safety Plan in advance of the Quarterly meeting

1. Declaration of Interests

No members declared an interest at the start of the meeting. The Chair advised that if any conflict of interest became apparent during the course meeting that members declare it and excuse themselves.

2. Review of the draft Community Safety Plan Actions

The working actions were circulated in advance of the meeting. There was some discussion in relation to the wording of the objectives and it was agreed to revise the order of priority areas 1 and 2.overall members were happy with the format .

Cllr Adejinmi requested that the category of actions be included – it was advised that this would be done for the next meeting.

Antoinette Kinsella (MRDATF) and Anthony O Prey (HSE) advised they would revert with specific wording for their organisations actions. The Coordinator advised they were also liaising with Longford Community Resources Clg and Longford Women's Link on specific wording for actions to be led by those organisations. It was confirmed that







the Chief Superintendent of An Garda Síochána had reviewed the actions relating to them.

It was agreed that final draft of the Action plan element of the Community Safety Plan would be brought to the Quarterly meeting on 13 June for consideration and approval.

Members were advised to revert with any further observations by the end of the week.

3. Review of proposed funding application for the Community Safety Innovation Fund from Longford LCSP.

The Coordinator gave an overview of the 2 draft applications which had been circulated in advance:

- All Island Community Safety Conference (Joint application on behalf of the pilot LCSPs and the Drogheda Implementation Board)- €14,450
- Cornerstone initiatives to support the delivery of Longford Community
 Safety Plan 2022-2023- €154,960

It was noted that the initiatives included in the applications would greatly support the work of the LCSP in building capacity and working relationships as well as improve community safety. Following a brief discussion and on the proposal of Karen Reilly, seconded by Superintendent Seamus Boyle both applications were approved for submission to the Department of Justice.. The Chair thanked the Coordinator for work in putting the applications together and for working with the other LCSPs to prepare a joint application.







4. To confirm arrangements for the Q2 LCSP meeting- scheduled for 13th June 2022

Arrangements were agreed for the meeting- which will be the first hybrid meeting. The physical venue will be the Council Chamber of Longford County Council.


