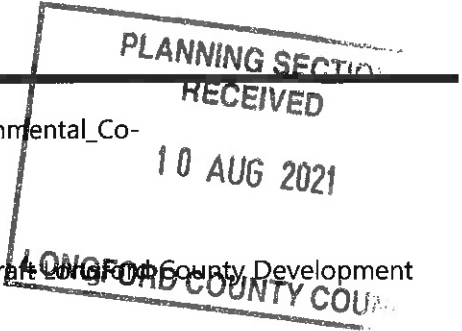

Notice is hereby given that the Members of Longford County Council, having considered the Draft Longford County Development Plan 2021–2027 and the Chief Executive’s Report in respect of submissions received, have resolved in accordance with Section 12 (6) and (7) of the Planning and Development Act 2000 (as amended), that the Draft

Development Plan be amended. The proposed amendments constitute Material Alterations to the Draft Longford County Development Plan 2021-2027.

The likely significant effects on the environment of implementing the proposed Material Alterations have been assessed. In accordance with Section 12 of the Planning and Development Acts 2000 (as amended), Longford County Council has screened the Proposed Material Alterations and has determined that Strategic Environmental Assessment (SEA) and Appropriate Assessment (AA) are required with respect to certain Proposed Material Alterations.

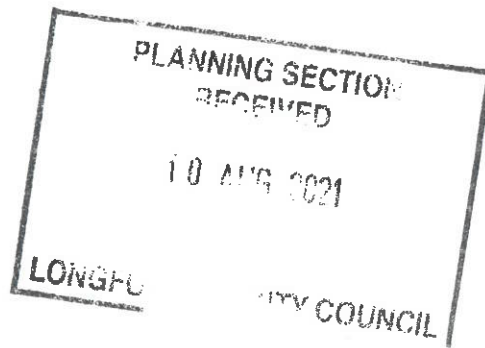
