Notice is hereby given that in accordance with the requirements of the above regulations that Longford County Council proposes to undertake the following works:

"Construction of Community Walk, to include upgrade of existing laneway, provision of new path, new bridge, fencing and ancillary works in the village of Lisryan."

The development will consist of:

The construction of a community walk c.2.5kms in length, approximately 3m wide through the townlands Lisryan & Drumman, to enhance existing laneway, construct new path, new bridge, fencing, to accommodate both pedestrians and cyclists and ancillary works in the village of Lisryan.

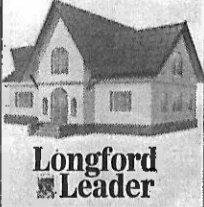
