Notice is hereby given in accordance with the requirements of the above regulations that Longford County Council proposes to undertake the following works:

Construction of a School Zone and ancillary works at Scoil Mhuire, Newtownforbes, Co. Longford, along the L-1004-0 Road and the Construction of a new controlled crossing on the N4 at Newtownforbes, Co. Longford.

The development will consist of:

- Demolish section of existing boundary wall of Scoll Mhuire N.S. fronting onto the L-1004-0 road and reconstruct new set back boundary wall to facilitate a 2.5m footpath and 3m wide bus bay.
- Demolish the existing wall around area currently used for staff parking and adjacent vehicle entrance to the North and construct new boundary wall and entrance piers including gates to be offset approximately 2m-3m from the edge of the existing road.
- Relocate and upgrade existing uncontrolled pedestrian crossing point on the L-1004-0 to a controlled crossing located in line with the main school pedestrian entrance.
- Junction tightening at the junction of the N4 and the L-1004-0 local road to include realignment of junction, landscaped build outs and installation of school approach bollards.
- Relocate and upgrade existing uncontrolled pedestrian crossing point on the N4 outside the playground to a new controlled crossing located approximately 25m North East of the current location.
- Provision of signage, road markings, road surface treatments, drainage, landscaping and ancillary works.
