**Proposed alteration and extension of No. 5 The Hollows, Glack, Co. Longford N39 X9X6 and all associated works.**

**The proposed development will consist of an alteration to the Ground floor layout at 5 The Hollows with removal of a portion of the South-West Gable wall. A cavity wall constructed extension to the South-West gable of the existing dwelling. A pitched roof will be tiled using material similar to existing. Existing foul and storm layout alterations will take place. Boundary wall and gate will be realigned in correspondence with new vehicular entrance.**
