8. NOTICE OF MOTIONS

The following Notice of Motion was proposed by Councillor Sean Mimnagh and seconded by Councillor Mick Cahill

I call on Longford County Council to take immediate action to identify and secure an alternative site for a children's playground in Kenagh village as the lease on the existing playground is due to expire in 2026

Response:

The playground in Kenagh was constructed in 2024 with LEADER funding provided to Kenagh and District Development Association. There are a number of options available to Kenagh and District Development Association.

- Secure the renewal of the lease.
- Consider applying for LEADER funding for the provision of a playground on an alternative site. The committee can contact LCRL for further information on the requirements for LEADER funding.
- Consider applying for CLÁR funding. This funding has been available for the provision of playgrounds in recent years and a number of communities in Longford have been successful in securing funding for playgrounds. It is anticipated that the 2025 CLÁR Programme will be announced in the coming months.

Longford County Council is available to advise the group in relation to the process and will continue to provide maintenance and upgrade works where necessary until the lease expires.

The following Notice of Motion was proposed by Councillor Sean Mimnagh and seconded by Councillor Mick Cahill

I'm calling on Longford County Council to carry out the necessary works to tighten the junction that leads to Lanesboro Primary School, and to provide a Pedestrian Crossing to ensure the safety of school children and other pedestrians.

Response:

The Active Travel section will make an application to the NTA (National Transport Authority) under the junction tightening funding category when funding allocations come available, likely to be in 2026.

The 2025 funding allocations for Longford from the NTA is currently fully committed.

The following Notice of Motion was proposed by Councillor Pat O'Toole and seconded by Councillor Mark Casey

I call on Longford County Council to assess the possibility of providing a footpath on the R392 from Peter Hanly Motors in Terlicken to the entrance of the Royal Canal Greenway and to include the project in the next round of funding under the Outdoor Recreation Infrastructure Scheme.

Response:

This can be considered under the next round of ORIS applications in 2026.
