The members thanked the Director of Services Barbara Heslin and her staff and all those involved for keeping the members updated during storm Éowyn. They complemented the response by the Council to fallen trees and the humanitarian response. They highlighted the costs associated with the storm and the issues experienced with the restoration of power, water and broadband. They suggested that generators be provided by Uisce Eireann in the water treatment plants, ESB maintain the corridor through the forestry for power lines and consideration be given to undergrounding cables.

5. TOWN TWINNING

6. UPDATE ON ESTABLISHMENT OF GRANARD TOWN TEAM

Donagh MacArtain gave a presentation on the establishment of the Granard Town Team. The focus of this team would involve the revitalisation and regeneration of the town centre. This team would work with the Council and external agencies to form an inclusive society for the people of Granard. The first public meeting will take place on Tuesday 4 February. The members agreed that the Granard Town Team was welcomed. The Members raised questions on their concerns to Mr. MacArtain, Consultant and Lorraine O'Connor A/Senior Engineer who both responded to their queries.

7. NOTICE OF MOTIONS

The following Notice of Motion was proposed by Councillor Padraig McNamara and seconded by Councillor Turlough McGovern

I call on Longford County Council to have a 3-year footpath plan, similar to the 3-year road plan.

Response:

The repair and upgrade of footpaths is funded from Longford County Council's limited own resources, or the Discretionary Maintenance funding provided by the Department of Transport. However, at the Finance meetings in 2024, the Elected Members approved the 5 year Strategic Business Plan. This plan commits to the funding of footpath repairs in the Longford Municipal District which will be funded from a specific loan. A commitment was also given that any funding arising from the IPB Capital Redistribution Fund over the period will be used to fund works in Granard and Ballymahon Municipal Districts. Once this funding is confirmed, the team in the Granard MD will prepare and prioritise a work programme. This will be done in consultation with the MD members.
