I am calling on Longford County Council to write to the Minister for Communications to express concern over the ongoing failure to restore telephone lines, fibre broadband in certain areas affected by Storm Éowyn, several weeks after the event.

This disruption has left many, including vulnerable and elderly individuals, without a vital means of communication in some cases, panic buttons used by older people to summon help in emergencies are inoperable due to the lack of a functioning landline.

This situation is putting lives at risk, as people are unable to contact family members or emergency services to ensure their safety and well-being.

Response:

Currently, there are still premises in county Longford without broadband connectivity. The progress in repairs has been extremely slow and frustrating. The quality of communication is practically non-existent.

We need a solution from our broadband infrastructure providers to provide real time information about restoration like ESB. The lack of communications has been highted with the national response team and the department.

Longford County Council will write to the Minister of the Department of the Environment, Climate and Communications in relation to the above notice of motion.

The members unanimously commended Christine Collins, Broadband & Digital Officer with Longford County Council on her great work and congratulated Christine on her recent achievement on winning a prestigious women in digital award.
