Suspension of Standing Orders - Discussion on Relocation of Physiotherapy Unit

On the proposal of Councillor Paul Ross, seconded by Councillor Seamus Butler, the members unanimously agreed to suspend Standing Orders to discuss the proposed relocation of the physiotherapy unit at St. Joseph's, County Longford, to either Athlone or Mullingar.

The members unanimously expressed the importance of retaining this vital facility in County Longford, highlighting the essential service it provides to the people of the county.

There was unanimous agreement among the members to confirm the full support of Longford County Council in ensuring that this facility remains within County Longford. The members also emphasised that the support of Oireachtas Members is critical in securing a positive outcome.

The members called on HIQA to identify and provide a suitable temporary location for the physiotherapy unit in County Longford during the ongoing works at St. Joseph's. This measure is essential to ensure the continued delivery of vital services to the people of County Longford without interruption.

6. SOCIAL DEVELOPMENT

(I) Consideration of draft County Longford Outdoor Recreation Plan 2025-2030

- online presentation by Outscape consultants

Outscape Consultants, represented by Caro-Lynne Ferris, delivered a comprehensive presentation to the Elected Members on the draft County Longford Outdoor Recreation Plan (CORP) 2025–2029. The presentation provided an in-depth overview of the plan's development, purpose, and proposed strategic direction. Caro -Lynne discussed all questions and comments raised by the Members.

The presentation covered the following key areas:

- Introduction: An overview of the purpose and scope of the Outdoor Recreation Plan, including its role in supporting health, wellbeing, tourism, and rural development across County Longford.
- Strategic Context: A summary of relevant national, regional, and local policies that inform and align with the plan, ensuring consistency with broader strategic objectives.
- Consultation Summary: An outline of the stakeholder and public consultation process, including engagement methods and key feedback themes that informed the draft plan.
- Current Situation: A detailed assessment of existing outdoor recreation infrastructure and resources within the county, identifying both strengths and areas for improvement.
- Strategic Objectives and Action Plan: A presentation of the plan's core objectives and corresponding actions aimed at enhancing outdoor recreation opportunities over the 2025–2029 period.
- Appendix 1 Definition of Outdoor Recreation: A clear definition outlining the scope of outdoor recreation considered within the plan, encompassing a wide range of activities in natural settings.

The Members welcomed the presentation and acknowledged the importance of developing a strategic framework to support and enhance outdoor recreation in County Longford.

(ii) Climate Action Plan 2024-2029

Bernard Shea, Climate Action Coordinator, presented to the Elected Members an update on the progress made to date regarding the Climate Action Plan 2024–2029, following its approval earlier in 2024.

The presentation covered the following key areas:

- Overview of the Longford County Council Climate Action Plan 2024–2029
- Progress highlights for 2024–2025
- Examples of Community Climate Action Projects

- Developments in New Social Housing and Housing Retrofits
- Upgrades to Public Lighting
- Initiatives in Active Travel
- Improvements to Drainage and Bridges
- Expansion of Electric Vehicle (EV) Charging Infrastructure
- Adoption of Electric Vehicles

A comprehensive review of progress under the County Longford Climate Action Plan will be made available on the Council's website.

Bernard and the Management Team addressed questions raised by the Members during the presentation. The Members unanimously thanked Bernard for the presentation and complemented the team on progress to date.

The members raised questions around the timeframe for the completion of the house retrofitting programme. Chief Executive Paddy Mahon explained that the retrofitting schedule is based on funding allocated by the Department. The progress of the retrofitting work will depend directly on the amount of funding received.

(iii) Notice of Motions

The following Notice of Motion was proposed by Councillor Mick Cahill and seconded by Councillor Pat O'Toole

I call on Longford County Council to through the relevant SPC, review its current policy on Traffic Calming Measures throughout the County in our Towns, Villages, Residential Areas and on approach roads to Rural Schools in the interest of road safety.

Councillor Cahill stated that the current road safety measures in County Longford are not effective and called for a thorough reconsideration of how the local authority implements these measures. He specifically highlighted serious concerns in Kenagh, where motorists entering the village from the Longford and Ballymahon directions frequently travel at high speeds. Councillor Cahill emphasised the urgent need for appropriate safety interventions, particularly given the presence of a school and residential estates in the area. He stressed that the safety of residents and road users is of paramount importance.

Response:

Longford County Council Road Design Section is reviewing the current Traffic Calming Policy. As part of the review, the team is consulting with colleagues in Active Travel and with the Municipal District Area Engineers. The main objectives of the Policy are to improve road safety in towns and villages, reduce and control vehicular speeds, improve driver awareness of vulnerable road users, enhance

the environment and reduce noise, disturbance and anxiety in the area being assessed.

It was agreed that, as a first step, proposals for inclusion in a Draft revised Traffic Calming Policy will be presented to the Physical Development SPC for consideration and discussion.

The following Notice of Motion was proposed by Councillor Pat O'Toole and seconded by Councillor Mick Cahill

I call on Transport Infrastructure Ireland and Longford County Council for an update on the preferred route option on the N.55 between Ballymahon and Athlone. What is the current timeframe for the delivery of this much needed project.

Response:

Westmeath County Council in partnership with Longford County Council and in association with Transport Infrastructure Ireland announced the Preferred Route Corridor (PRC) for the N55 Athlone to Ballymahon Scheme on the 10 May 2023. As the N55 Athlone to Ballymahon Scheme was not listed in the current National Development Plan (NDP) it was decided to advance the Scheme on an incremental basis (i.e. scheme divided into 4 or 5 phases). The proposed first phase is the by-pass of Ballykeeran Village.

It was agreed that Longford County Council will write to Transport Infrastructure Ireland requesting an update on the scheme.

The following Notice of Motion was proposed by Councillor Paul Ross and seconded by Councillor Gerry Hagan

That Longford County Council call on the Minister for Climate, Environment and Energy Darragh O'Brien to open up the Domestic Waste Water Treatment grant to all those whose septic tanks need upgrading who wish to apply for it. The current scheme has 3 criteria which are:

- Grant under the National Inspection Plan.
- Grant in Prioritised Areas for Action.
- Grant in High Status Objective Catchment Areas.

County Longford has no areas in prioritised areas for action or high status objective catchment areas which means that unless a house is inspected and fails the criteria, Only then can it apply for the grant which the grant almost unattainable in County Longford in its current format.

Response:

The current Domestic Waste Water Treatment (DWWT) grant system uses a risk-based, targeted approach to ensure national funding is directed where it will have greatest impact (i.e. Prioritised Areas for Action and High Status Objective Catchment Areas) to meet Ireland's Water Framework Directive (WFD) obligations under EU law.

Under the Environmental Protection Agency's (EPA) Recommended Minimum Criteria for Environmental Inspections (RMCEI), the Environment Section of Longford County Council has committed to 10 no. DWWT inspections for 2025 under the National Inspection Plan (NIP), and well over the 4 no. minimum prescribed by the EPA. Assessment is based on each Local Authority's own desk-based analysis.

Grant applications or requests from members of the public without a prior inspection from the Local Authority are not considered.

To expand the criteria for grant aid beyond the existing will ultimately lessen the scheme's environmental impact, divert limited resources away from the most urgent and sensitive cases, and weaken Ireland's compliance with EU directives.

Finally, opening a DWWT grant application to all would drastically increase workloads and administration demands requiring additional staffing provision.

It was agreed that Longford County Council will write to the Minister for Climate, Environment and Energy outlining the proposal as outlined in the Notice of Motion.

The following Notice of Motion was proposed by Councillor Paul Ross and seconded by Councillor Mick Cahill

I call on Longford County Council to seek a meeting with senior management of Uisce Eireann to resolve the serious issue of the water main upgrade from Carrickboy to Ballymahon. This main is bursting on a daily basis causing hardship for families, businesses and farms and there is no information available as to when the upgrade is due to start or what is causing the delay. This level of service is unacceptable, and this issue needs to be resolved as soon as possible.

Response:

It was agreed that Longford County Council will write to Uisce Éireann regarding the Notice of Motion.

The following Notice of Motion was proposed by Councillor Pat O'Toole and seconded by Councillor Martin Monaghan

I call on the Department of Health and Children and the HSE to immediately commence a recruitment process for the staff required to carry out Assessments of Need for children on the waiting list for Special Education Supports, in light of recent media reports that the waiting list for the assessments could increase to a very alarming level of 15,000.

Response:

It was agreed that Longford County Council will write to the Department of Health and Children and the HSE regarding the Notice of Motion.

The following Notice of Motion was proposed by Councillor Garry Murtagh and seconded by Councillor Gerry Hagan

I call on Longford County Council to write to the Minister Dara Calleary with responsibility for the Department of Social Protection, to conduct a full review of Community Employment, Rural Social Scheme (RSS) and the Tus initiative, with particular attention to the minuscule top-up payment to people that avail of or are activated on the current schemes and to include a full review of supervisor's salaries and pension entitlements, which need to be index linked to at least a grade 4/5 of a civil servants rates with the implementation of the same.

These schemes play an important and integrate role within our communities, up and down the country and the lack of respect and fair play being shown to these workers is unjust. Without their support within such areas as, childcare/social care/ Tidy Towns, to name but a few would see the very fabric of our society deteriorate even further.

Response:

It was agreed that Longford County Council will write to Minister Dara Calleary regarding the Notice of Motion.

Chief Executive Paddy Mahon, on behalf of the management and employees of Longford County Council, expressed his sincere appreciation to the Cathaoirleach for his support and leadership throughout the year.
