Chief Executive Paddy Mahon outline the progress to date on the Corporate Plan.

- (ii) **CE REPORT NPF IMPLEMENTATION: HOUSING GROWTH REQUIREMENTS**

Senior Planner, Louise Kiernan outlined to the Members NPF Implementation: Housing Growth Requirements Guidelines which highlighted the following:-

- NPF Ministerial Guidance Requirements – Guidelines Housing targets for Longford 2025-2034:  
428 per annum – sufficient zoned lands should be available.  
Consider additional provision of up to 50% over and above the housing growth requirement.
- Existing Development Plan – Review Housing Supply Targets (HST)  
Annualised target (428 units per annum).  
No uplift in existing HST required from the guidelines target.
- HST Progress on New Residential Lands to Date (2021 – 2025)
- New Residential Zoned Lands
- Strategic Residential Reserve' Lands
- Other Considerations

- Conclusion and Recommendation – As per the existing County Longford Development Plan 2021-2027, the existing core strategy is considered in compliance with the 'NPF Implementation: Housing Growth Requirements' for the remaining timespan of the Plan (2 Years) and therefore no change or variation is recommended.

The Elected Members commended the work carried out by Louise and her team in the Planning Department. Louise provided responses to the queries raised by the Elected Members.

The Elected Members considered the report and approved the recommendation of the Chief Executive. The report will now be submitted to the Minister and the OPR.

**(ii) REVIEW OF NOAC PERFORMANCE INDICATORS 2024**
