### **CLÁR 2021**

CLÁR is a targeted investment programme for rural areas funding small-scale infrastructural projects in disadvantaged areas. It aims to support sustainable development by attracting people to live and work in these areas.

In October, CLÁR funding of €344,227.34 for County Longford was approved. Longford County Council will fund up to 5% towards the estimated cost of projects, all of which started in 2021 and are due to be completed in 2022.

### Community Grant Support Scheme 2021

The Community Grant Support Scheme supports projects that make a positive contribution, develop strong local communities, and improve the quality of life of citizens.

Under this Scheme, countywide funding of €19,658, Longford Municipal District (MD) funding of €99,700, Granard MD funding of €63,439 and Ballymahon MD funding €71,475 was awarded.

### Longford Comhairle na nÓg

Longford Comhairle na nÓg help ensure the voices of young people are heard and represented. Longford Comhairle na nÓg secured €20,000 in funding from the Department of Children, Equality, Disability, Integration and Youth to operate in 2021.

Longford Comhairle na nÓg Annual General Meeting (AGM) was held in November with 71 young people, representing all nine post-primary schools and youth services in County Longford in attendance. The Longford Comhairle na nÓg Steering Committee held four meetings in 2021. Members held 35 meetings and eight subcommittee meetings in 2021.

Members participated in several national consultation forums such as the National Climate Action Plan, United Nations Convention on the Right of the Child consultation on experiences of being a child in Ireland and on a Rural Youth Assembly. Members had training on committee skills, communication and presentation skills, facilitation, and team building. Members also worked on a climate project and an outdoor summer camp.

### Longford Intercultural Working Group

Longford Intercultural Working Group provided a forum to share information, to promote inter-agency cooperation and coordination for the delivery of services. The group held four meetings in 2021. Support continued for community groups as part of the Longford County Council Intercultural Fund to engage new communities and promote integration.

Around €28,000 in grants was used by groups and in supports of services working with new communities. For example, grants were allocated to Longford Women's Link to work with a migrant women's group, to Midlands Polish Community for an information desk supporting Polish nationals, and to the Ethnic Minority Hub to print a magazine created by the African community. The Family Resource Centres were also allocated funding for translation services to support their work with the more disadvantaged communities.

### Sláintecare Healthy Communities

Sláintecare Healthy Communities was launched in October. Longford County Council are represented on an implementation group for Longford and Westmeath. Groups in Longford were selected to deliver a social prescribing, a parenting, and a smoking programme in County Longford.

€75,000 will be made available to support the delivery of the Sláintecare Healthy Communities programme. A Local Development Officer will be employed to engage with communities and local groups to address the wider determinants of health.

€250,000 was secured for enhancement work under the Sláintecare Healthy Communities programme. This includes the installation of cycleways, enhanced pedestrian connections, and environmental improvements at Ballyminion.

### Longford Local Community Safety Partnership

Longford Local Community Safety Partnership (LSCP) 24-month pilot was established in June 2021 and replaced the Joint Policing Committee.

It has 30 members which were nominated by Longford County Council, statutory bodies, local organisations, and Longford Public Participation Network. A Community Safety Coordinator was appointed and the first meeting of the LCSP took place in September.

The initial aim is to raise awareness of the initiative and to engage in a countywide public consultation. This will identify the main community safety concerns and priorities and enable the development of a Community Safety Plan to address safety issues.





### Community Resilience Fund

Funding to the Council for the delivery of actions under the Community Resilience Fund was approved in 2021. Target groups for these actions included vulnerable older people, people with disabilities and local community groups.

Community Resilience Fund programmes included an information pack for older people, health and wellbeing programmes for Community TV, Longford Keep Well Health and Fitness Challenge 2021, Switching Off with Music, local radio programmes, Longford Women's Link Domestic Violence Service, and an Age Friendly Communications Directory.

The Council worked with partners including Longford Libraries, Longford Age Friendly, Longford Local Sports Partnership, Longford Community Resources CLG, Longford Older Persons Council, Longford Public Participation Network, and Longford Women's Link.

### Disability Participation and Awareness Fund

Under the Disability Participation and Awareness Fund, €75,000.00 was made available for disability awareness training, town accessibility improvements, sports equipment and a social farming project.

### LGBTI groups Dormant Accounts Funding

Dormant Accounts Funding of €21,500 was secured to run projects for the LGBTI community in conjunction with community groups.

#### Pride Month

In May, a local LGBTI youth group presented then Longford County Council Cathaoirleach Cllr Paul Ross with the Pride Flag to fly on the Council building during the month of June in recognition of Pride Month and to show support for the LGBTI community in County Longford.



### Connecting Women to Local Government

In collaboration with Longford Public Patricipation Network, Longford Women's Link and the See Her Elected programme, the Connecting Women to Local Government booklet was produced. The publication aims to help more women and people from diverse backgrounds get involved in local government.

### Africa Day

Longford African Network were supported in an online celebration of African Day. An evening of entertainment included an award for members of the African community and those who have made a significant contribution to Longford's African community.

### Longford Local Community Development Committee

Longford Local Community Development Committee (LCDC) brings together Elected Members, state agencies and individuals working within community development, and economic, cultural, and environmental organisations. This cross-sectoral group brings a joined-up approach and coordination to local and community development.

Seven LCDC meetings were held in 2021. The committee's main tasks are to develop and implement the Local Economic and Community Plan for the county and coordinate, plan, and oversee local and community development funding.

#### **LEADER**

LEADER, a rural development programme, is administered by Longford LCDC in partnership with the Council and Longford Community Resources CLG. In 2021, 21 LEADER projects valued at €1,437,663.59 were approved. Following payment by the Department of Rural and Community Development, the Council processed 47 grant payments totalling €1,979,935.63.

### Social Inclusion Community Activation Programme

The Social Inclusion Community Activation Programme (SICAP) provides funding to tackle poverty and social inclusion at a local level. Longford LCDC awarded Longford Community Resources CLG the contract to implement SICAP. The SICAP budget for 2021 was €526,906. €33,034.25 was also carried over from 2020, leading to a total budget of €559,034.25.

### Community Activities Fund

Under the Community Activities Fund, €264,769 was allocated to Longford LCDC. The fund supports community groups, particularly in disadvantaged areas, with running costs, equipment costs and repairs and improvements to facilities. Grants will be awarded in 2022.

### County Longford Pilot Community Development Programme

A County Longford Pilot Community Development Programme to put in place a community development project managed by members of Roma and new communities was allocated €125,000. It was allocated to Longford County Council, to be administered to Longford Community Resources CLG, under the guidance of Longford LCDC.

### Community Enhancement Programme 2021

Longford LCDC awarded €132,385 to 76 community group projects under the Community Enhancement Programme for the enhancement of community facilities in disadvantaged areas. This is funded by the Department of Rural and Community Development and administered by Longford LCDC.

### Social Enterprise Capital Grants Scheme 2021

In 2021, €24,411.61 was awarded to six social enterprises in County Longford under the Social Enterprise Capital Grants Scheme. This scheme provides small capital grants to social enterprises. It is administered by Longford LCDC.

### Healthy Ireland

Healthy Ireland aims to create a society where good physical and mental health is enjoyed by all. The Healthy Ireland Fund supports innovative, cross-sectoral, evidence-based projects that support national policies in areas such as obesity, smoking, alcohol, physical activity and sexual health.

€246,050 was allocated under round three of the Healthy Ireland Fund, which runs from July 2019 to March 2022. Actions included the following:

### COVID-19 Emergency Fund 2020

Early 2021, Longford LCDC were awarded €42,964 for grant for 35 community groups. This funding assists community groups in adapting their operations to fit the new COVID-19 reality and to become more involved in the Government's 'Keep Well' campaign.

## **Public Participation Network**

### Membership and Meetings

In 2021, County Longford Public Participation Network (PPN) registered 24 new groups, bringing its total group membership to 474.

The County Longford PPN Secretariat consists of nine voluntary members elected to oversee the work of the PPN. In 2021, elections were held for a community vacancy on the County Longford PPN Secretariat, with one representative elected to the Secretariat.

County Longford Plenary meeting of the PPN was held in November. A representative from Social Justice Ireland also spoke about the future of PPNs.

### Connecting Women to Local Government

In collaboration with the Community section, Longford Women's Link and the See Her Elected (SHE) programme, €5,000 in funding was secured. The aim of this funding was to increase the presence of women and individuals from diverse backgrounds in local government. This funding was utilised for the Connecting Women to Local Government booklet. It outlines how local government functions and highlights opportunities for getting involved. It has been translated into Polish, Lithuanian, Slovak, Latvian and Portuguese. Longford PPN intercultural representative were featured in a short promotional video for the publication.



### COVID-19 response

In the continued response to COVID-19, County Longford PPN were represented on the Community Response Forum and involved in rolling out many initiatives.

For the national Keep Well campaign, Longford PPN's collaboration with the Irish Countrywomen's Association (ICA) guilds was extended to 28 February 2021. For this, each guild made sure people in the area who are living alone received phone calls and letters to help to combat isolation.

## **Public Participation Network**

### Minority women's group

The PPN funded and supported the establishment of a minority women's group. This group were provided with information on services available to them, including on early years services, domestic violence support and training and education opportunities.

The group explored the SHE programme and a personal effectiveness programme. This community collaboration with Longford Women's Link, Lus na Gréine and Bridgeways Family Resource Centre (FRC) Ballymahon. In all, 26 women participated in this group.

### Operation Blue Santa

Longford PPN teamed up with Granard and Longford Municipal District Community Gardaí for Operation Blue Santa to raise awareness and funds for organisations who work with families in need.

For this, the Garda Band performed a concert in St Mel's Cathedral. Over €6,000 was raised. An Operation Blue Santa children's book and Christmas cards were also launched. Funded by Longford PPN, the book was written by journalist Jessica Thompson and illustrated by artist Nicole Forster. Over €6,000 was raised. The money benefitted ten charities.

### Sustainable Development Goals

Three online workshops on Sustainable Development Goals (SDGs), which help us achieve better and more sustainable future, were delivered. These workshops covered Fairtrade and ethical consumption matters, women, wellbeing, climate change and a youth-led workshop called Protecting the Planet, the Animals and the People. The SDGs were tied into Longford PPN Community Wellbeing Vision Statements.

### Citizenship and Democracy Programme

Longford PPN was the first PPN in the country to get involved and sponsor the Citizenship and Democracy Programme. This is a government, local government and European Union-funded programme for Irish secondary schools. It aims to engage, inform, and inspire young people. Students have the opportunity to experience how European democracy works by visiting the European Parliament in Strasbourg. Moyne Community School student Sebastian Scheiner was one of the prize winners under this programme.

### Football camps with Longford Football Association of Ireland

Longford PPN Development Officer and Longford Football Association of Ireland (FAI) Development Officer collaborated on summer football camps rolled out for 15 children with autism. This type of initiative with FAI involvement was a first for the country, with the FAI planning to roll it out elsewhere.

Since this summer camp, parents have completed FAI safeguarding and disability awareness training. They also participated in a five-week autism programme in Edgeworthstown. This involved parents assisting as coaches, with a view to building a club in Longford that can implement a 'Football for All' structure. This will help these type of community programmes to become more sustainable.

### Running and walking

Over 100 participants took part in our 6 weeks virtual beginners 5K Your Way programme with Longford Athletics Club, weekly training plans with podcast and video advice; weekly online exercise session and Strava Club in run up to the Longford Athletics Club St Patrick's Day Virtual Ireland Run.

Be Active Night had 150 participants register to walk or run the Ready, Set, Glow 5K.







468 people registered for community and virtual walks as part of the Summer Walking Series. Guides for each walk included a description and video of the trail. This programme was delivered with Longford Tourism.

Walking with Poles Programme for older adults had over 200 older adults take part in locations around County Longford.

#### Soccer

Seven Football Association of Ireland (FAI) camps had 360 participants. This included a FAI summer camps and a Football for All (FFA) camp. The latter FFA camp led to a five-week Autism programme which will become part of the first FFA Club in Longford, as part of Melview Football Club in 2022.

Eight County Longford soccer clubs have registered for FAI Club Mark, an award based on best practice in the governance, management, and administration of a football club. Two further clubs have achieved the Entry-Level Award.

Ireland U19 International player, Rebekah Carroll assisted in the delivery of the FAI Intercultural school programme with four schools in Longford. Show Racism the Red Card initiative was delivered through schools to raise awareness of racism.

Additionally, a volunteer recruitment workshop was delivered. This led to a volunteer open day with UCL Harps soccer club. 21 people participated, which led to eight new volunteers at the club.

### Cycling

For Bike Week 2021, 328 people cycled along the Royal Canal Greenway. 267 participants took part in the Transition Year Greenway Cycle, 41 participants took part in the Royal Canal Family Cycle and 20 participants took part in the Greenway Guided Cycle Tour.

Additionally, hundreds of primary school students took part in the Safe Cycling in Longford competition.

### Kayaking, Canoeing and Paddleboarding

Women on the Water and Men on the Water programmes had 131 participants achieve their Canoe Ireland Kayak proficiency skills certification. 52 participants registered to get in their kayaks for the 10km Blueway Challenge.







Up to 83 children participated in children's paddleboarding and kayaking programmes. Meanwhile, the school water sports programme had 406 primary school students and 207 transition year students experiencing kayaking and paddleboarding.

### Horse Riding and Welfare Programme

The Horse Riding and Welfare Programme had 15 young people from the travelling and Roma communities and from low-income backgrounds learn about horses, responsible horse ownership and career opportunities working with horses. This six-week programme was run with Longford Community Resources CLG, in association with the Department of Agriculture.

### Sports Inclusion Disability Programmes

Under Sports Inclusion Disability Programmes, 413 people with disabilities participated in 22 initiatives. Programmes included horse riding, water sports, athletics, Zumba and fishing and were run through disability services, schools and sports clubs. Programmes were supported by the Health Service Executive (HSE), Healthy Ireland, and Sport Ireland.

One such programme included the Woodlands for Health initiative in which participants were referred from HSE Mental Health Services. Five walks took place, with transport and refreshments provided.

### Healthy Ireland Funded Programmes

The Balance Ability programme had 384 children from nine preschool and childcare services using unique ergonomic balance bikes. 720 primary school children participated in the Longford Sports Hall Athletics Programme. Parkour programmes continued to be delivered to schools. 942 young people participated in 2021.

### Drumlish Community Sports Hub

Over 150 adults and children have participated in activities in Drumlish Community Sports Hub since its official opening in October 2021.

Highlights of activities at the hub include a kids Halloween camp which was attended by 30 children taking part in soccer, hurling and football. Children's basketball and hip-hop dancing classes have also taken place.

At Christmas, a concert and 5K fun run took place at the hub. The programme of activities were delivered by a new Sports Hub Coordinator who had recently started.

### Edgeworthstown Community Sports Hub

Edgeworthstown Community Sports Hub online classes including an Operation Transformation-style programme in which 68 participants were given a couch-to-5K programme and two weekly workouts.

International Women's Day was marked in the Hub with 22 women taking part in free online classes including Pilates.

### Training and education

Longford Local Sports Partnership delivered 45 training and education courses, workshops, and webinars to 888 people. This includes soccer coach education for over 181 participants.

### Funding

Club Development and Participation Grant supported 44 clubs with grants valued at €13,850. These grants are used to support clubs' junior structures, coaching and education initiatives and group programming.

COVID-19 Small Grant Scheme saw €40,422 awarded to 39 clubs in Longford. This scheme was implemented through Sport Ireland and Local Sports Partnerships.

In 2021, over €684,268 in direct funding and €107,433 in benefit-in-kind funding was secured by Longford Local Sports Partnership. This includes:

• €274,326 from Core Funding, Sport Ireland

- €8,400 from Women in Sport, Sport Ireland
- €151,450 from national and local funding from Longford County Council, the HSE, Department of Agriculture and Food, Age and Opportunity Ireland, Department of Children and Youth Affairs
- €24,334.63 from Sports Capital from the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media
- €59,000 from Healthy Ireland and the Community Resilience Fund
- €154,824 from the Dormant Accounts funding for the Community Sports Hubs in Edgeworthstown and Drumlish, Sports Inclusion Disability Projects, Youth Leadership, Urban Outdoor Adventure Initiative, Volunteer Supports, Aspire Graduate

## **Local Enterprise Office Longford**

### Training and Mentoring

Local Enterprise Office (LEO) Longford provided 57 training courses, in which 945 people participated. These courses included training on environmentally-sustainable business practices, digitalisation, and innovation and exporting.

Provided 141 people mentoring in areas including marketing, human resources and access to finance.

### Financial Support for Businesses

Supported the occupancy of vacant industrial units and the enhancement of shop fronts through the Business Incentive Schemes, which had nine approved applications in 2021.

New schemes in 2021 included the Streetscape Enhancement Scheme and Outdoor Seating and Accessories for Tourism and Hospitality Service grant. 60 businesses availed of funding under these schemes.

19 business availed of business priming and expansion grants. 32 business were approved Trading Online Vouchers.

### Student Enterprise Programme

Seven County Longford schools across participated in the Student Enterprise Programme, which helps foster entrepreneurial spirit in young people. Approximately 80 students participated in the County Final event.

Of the finalists, CMG Skinny Bottoms and Halfzips from Cnoc Mhuire Secondary School, Granard and Saoirse's Bakes and Cakes from Moyne Community School went through to the first round of the national finals. Saoirse O'Toole from Saoirse's Bakes and Cakes picked up the Best Endeavour prize in the intermediate category at national level.



## **Local Enterprise Office Longford**

### Increasing Investment

Supported county and regional committees in their work on projects to increase investment to the region. The Lanesborough Food Hub under Just Transition and co:worx digital hub in Edgeworthstown are prime examples of the type of projects that are undertaken to attract new enterprises, create new jobs and facilitate remote working.

LEO Longford also worked to develop new networks to create business partnerships, working with stakeholders to promote County Longford as a business location. For this, comprehensive follow up was also provided to those who expressed an interest in investing in Longford.

## **Longford Tourism**

### Longford.ie

Longford.ie was launched in February and host Longford Tourism under its 'Visit' section. Accessibility tools allow the website to be available in over 100 languages, which helps Longford Tourism in promoting the county across the globe.

### Royal Canal Greenway launched

The Royal Canal Greenway was officially launched in March by Waterways Ireland and Minister of Environment, Climate and Communications, Eamon Ryan TD. The longest greenway in Ireland, the route is great for walking and cycling. This key tourism offering has brought many visitors into the region.

Also known as the Famine Way, this amenity allows a tracing of history – remembering difficult journeys made by people form this region in the past. Longford's section of the greenway has storyboards along the route from Abbeyshrule to Clondra, informing people about the past, present, and future of the greenway.



### EZxploring maps and multilingual souvenir audio player launched

EZxploring maps were launched with seven walking trails to explore around the county, including Ardagh, Ballymahon, Longford Town, Edgeworthstown, Granard, Lanesborough. The Royal Canal Greenway and National Famine Way were also included in these maps. Stocked in attractions and libraries throughout the county, the maps make sightseeing fun and education for all ages.

Promotion of the EZxploring maps included a video shared ahead of the Halloween break to encourage people to get out and explore County Longford with their maps. A multilingual souvenir audio player was launched to complement Longford Town walking trail.

## **Longford Tourism**

### 'County by County' TV Series

County Longford took part in the Ireland 'County by County' series. Filmed in April, the series will be aired in the United States in Spring 2022 and will be shown on Aer Lingus inbound flights.

### Spring and summer promotion of County Longford

Two short promotional videos (Longford in Spring and Longford in Summer) produced by local company Harp Media were released during 2021 with great success and feedback. They feature things to do in Longford and are the final two videos in the series (two more videos, Longford in Autumn and Longford in Winter were previously launched in 2020).

County Longford was promoted online and in print as a place for a summer staycation. Longford Tourism collaborated with journalist and travel blogger John Quinn by organising an itinerary, activities, and accommodation. John documented this online through his website and travel blog.

### Collaborative Projects

Longford Tourism continues to collaborate with its many partners through its work in promoting County Longford. Partners include Failte Ireland and their Ireland's Hidden Heartlands' brand, Waterways Ireland, and the regional Upper Shannon Erne Future Economy Project (USEFE) group.

### 'Promoting Tourism Together' with Local Enterprise Office Longford

An example of Longford Tourism's collaborative approach is the 'Promoting Tourism Together' online networking event. Carried out with Local Enterprise Office Longford, over 50 tourism providers attended. There were presentations from Fáilte Ireland, Ireland's Hidden Heartlands and Longford Tourism. 'Elevator pitches' from tourism providers were also shown to highlight what Longford has to offer. Four follow-up workshops were held, as well as an 'Optimising your Digital Marketing Platforms' workshop for tourism businesses.

#### Podcast with In Hand Guides

Working with the company In Hand Guides, Longford Tourism created a series of podcasts promoting County Longford. The series will be launched early 2022.

### Healthy Ireland tourism trails

A new project with Healthy Ireland Longford on mapping out the tourism trails in County Longford started in 2021. These maps will be used for online promotion and will also be included in a Walking and Activities booklet. Work is continuing with the content and production of this booklet which will launch in quarter one 2022.

## **Longford Tourism**

### Festive funding supports

The Fáilte Ireland Regional Festival and Participative Events Fund was promoted by Longford Tourism. This included information distributed to festivals taking part in County Longford.

#### **Events Guide**

Longford Tourism's monthly Event Guides continued, with publication in the Longford Leader and on Longford.ie. Through these guides many things happening around the county were promoted. This included Longford Live and Local events, as well as festive events in the special Christmas Events Guide.

## **Longford Arts Office**

### Funding received

Longford Arts Office received approximately €1m in funding from Arts Council of Ireland in 2021.

Additionally, €282,800 in funding was received from the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media. This funding went towards Longford Live and Local, which supported more than 90 events across County Longford.

### Longford Live and Local

Longford Live and Local took place in two phases in 2021 with both summer and winter programmes. The Arts Office administered funding of €282,800 for these events by providing financial and event management supports for both phases. This funding was provided by the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media under their Local Live Performance Programming Scheme.





### In The Open Faoin Spéir Arts Festival

For the In The Open Faoin Spéir Arts Festival, funding of €89,814 provided by the Arts Council of Ireland. Longford Arts Office partnered with Backstage Theatre and Republic of Culture to curate a festival of events from local talent within the arts sectors. Events included concerts in Connolly Barracks in August. It also included an unique walking live-performance production of The Fabulous True and Timeless Tales of Sergeant Virgil in late October. This unique piece took audiences around the Camlin Quarter of Longford Town.

### Culture Night

Longford Arts Office supported Culture Night with €7,886 in funding towards the cost of the events taking place in County Longford in September.

### Register of Electors

2021/2022 Register of Electors came into force in February 2021. 33,398 people were registered to vote on this Register of Electors. This includes 11,113 in Ballymahon Local Electoral Area (LEA), 9,958 in Granard LEA, and 12,377 in Longford LEA.

### Official Languages Act

In December, the new Language Bill, which amends the Official Languages Act 2003, was passed in the Dáil. This legislation aims to strengthen the status of Irish in the state system. The bill has several objectives, including for 20% of public service new recruits to be required to work through Irish by 2030.

### Cumann na nOifigeach Forbartha Gaeilge

Cumann na nOifigeach Forbartha Gaeilge (COFG) is the Irish Language Development Officers Association. It had three online meetings in 2021. At these meetings, discussions focused on the new Language Bill, Seachtain na Gaeilge and the launch of COFG.ie.

In October, COFG received official recognition from the County and City Management Association (CCMA). It is hoped this status will give Irish Officers the opportunity to work with the CCMA to clarify the role of Irish Development Officers in Local Government.

### Data Protection

In 2021, Data Protection introduced a data protection compliance monitoring framework, as well as an innovative process for employee training. All data protection legal requirements were adhered to in 2021.

Data Protection policies in 2021 include the Data Protection Policy, Data Subject Rights Policy, Personal Data Breach Policy, Elected Representatives Representations Policy and the Longford County Council Privacy Statement.

### Civic Receptions

#### **Audit Committee**

The Audit Committee provide an independent expert review, assessment and advice on financial management and reporting processes, internal control systems and procedures, risk management and audit matters. Its role is primarily advisory. It met six times in 2021.

#### Communications

Longford County Council's Communications unit was established in early-2021 with the recruitment of a Communications Officer. This appointment is evidence of the Council's understanding of the importance of communicating with its many stakeholders.

#### Strategic Communications Plan 2021-2024

Strategic Communications Plan 2021-2024 was approved by Management. The work set out within this plan started, including an external review of communication taking place. This audit gave much valuable information and guidance that supported the Council's Communications team. Internal operational documents, including a Style Guide and a Publicity Protocol were also developed to help direct future communications.

#### Communications Activities

Throughout the year, 110 press releases were issued to local and national media, promoting the work happening throughout the Council. Communications also worked on many Council events, including the Civic reception for Shaunagh Connaire, and the Roscommon-Longford Garda Youth Awards. The Communications completed numerous publications, including the monthly Chief Executive Report and the Customer Services Charter.

#### #YourCouncilDay

#YourCouncilDay lets people know some of the many services the Council is responsible for. Our videos posted throughout the day showed many familiar faces at work! On Facebook, these videos reached on an audience of 8,771. They also gained 313 overwhelmingly positive reactions, including 58 shares. People also clicked on these posts 507 times, helping them to learn more about what the Council does.

### Longford Live and Local

Longford Live and Local, including Faoin Spéir and Culture Night, supported our many local entertainers, with the Council's social media promoting these events. On Twitter, 52 Longford Live and Local tweets earned 42,541 impressions and 1,189 engagements, with many clicking through to book their place at an event or two!

#### COVID-19 Social Media Communications

The Council worked hard to get the many different COVID-19-related messaging out to our citizens. On Instagram, the Council posted 81 times about COVID-19, including vaccinations, boosters, COVID-19 business supports and how to #KeepWell and #StaySafe. These posts reached 18,982 people, with 20,179 impressions and 344 likes.

### Social Media promoting the work of the Council

Social media also supported and promoted the work of many Council section. This included working with Environment to produce with 75 posts across our social platform. Topics included Longford's Green, Keep It Clean, sheep worrying, stopping food waste and waste collections. These posts gained 455 likes, with 65,634 impressions. Work was also completed with Longford Local Community Safety Partnership to introduce this new initiative and to promote different funding schemes, including CLÁR 2021.

### Health and Safety

#### ISO 45001:2018 Certification

Longford County Council's Health and Safety section maintained its ISO 45001:2018 certification following an audit completed by the National Safety Authority of Ireland. All Council sections were included in the audit. This international standard specifies requirements for an occupational health and safety management system which aims to prevent injury and ill-health.

#### Health and Safety Awards 2021

Longford County Council won the Regional Midlands award and Consistent High Achiever award at the National Irish Safety Organisation (NISO) Annual Occupational Safety Awards. Evidence of compliance to many aspects of health and safety throughout the Council had to be submitted as part of these awards.



### Safety Statement

Longford County Council and Fire Services Safety Statement were updated. Safety Statements specify how the Council manages health and safety. Longford County Council are the first local authority to obtain the 'plain English' make for their Safety Statement. This mark ensure the document is more accessible to people of different literacy levels and is obtained from the National Adult Literacy Agency.

### Safety Inspections

In 2021, 350 safety inspections were completed throughout all directorates in Longford County Council. These inspections help determine compliance with health and safety throughout the Council.

### Health and Safety Auditing

Longford County Council continued auditing the health and safety management system. Eleven days of internal auditing were completed in 2021. The National Standards Authority of Ireland (NSAI) carried out two audits over four days.

#### COVID-19

COVID-19 compliance was the responsibility of the Acting Health and Safety Officer, who met regularly with Management. The Council developed a COVID-19 Business Response Plan and Health and Safety developed risk assessments to help continue operational activities to safely during COVID-19.

### Library Visitors and Members

Visitor 43,308 across all County Longford library branches with 40,092 books and other items lent to people. There were 3,536 registered library members at the end of 2021.

### Edgeworthstown Community Library Opened

Edgeworthstown Community Library was officially opened by Minister of Community and Rural Development, Heather Humphries TD in November. This state-of-the-art library is key to the town's regeneration. It is the first civic building in the Midlands to meet the nearly zero energy building (NZEB) rating.

For the project, €2.4m was received under the Libraries Capital Programme. Additional funds were received from the Rural Regeneration and Development Fund. The overall cost of the development was just under €4.5 million.







### COVID-19 Outreach and Digital Services

Throughout COVID-19 restrictions, County Longford Library Services reached out and developed online services for the local community. 272 online events were delivered, included on coding, mindfulness, music, art, gardening, and digital skills. Digital services such as online newspapers, e-Books, and e-magazines were in demand.

All branches took part in Ireland Reads Day, Seachtain na Gaeilge, Cruinniú na nÓg, Bealtaine and much more. Videos of these events attracted 83,500 view online.

#### Grow it Forward

Grow it Forward launched in March. This gardening initiative would inspire people to grow their own food and plants. Seed packs were delivered to libraries and over 3000 packs were distributed to individuals, schools, and community groups around the county.

### Granard and East Rouen Official Town Twinning

An Official Twinning Agreement between Granard and East Rouen in Normandy, France was signed by the French Ambassador and Council Cathaoirleach Cllr Peggy Nolan and Chief Executive Paddy Mahon.



### Digital Skills Training

Basic digital skills training for citizens wishing to increase their experience of technology was delivered online. This courses was brought to Broadband Connection Points across Longford with the help of the Council's Broadband Officer. Through digital equity and social inclusion funding, 10 Acorn Age Friendly digital tablets were purchased for training for older citizens.

### Touch, Type, Read, Spell (TTRS) Literacy Programme

Through the Department of Community and Rural Development under the Dormant Account Fund, 50 Touch, Type, Read, Spell (TTRS) licences were purchased to assist young people with learning challenges such as Dyslexia and Dyspraxia. TTRS licences were distributed through library branches, schools, home school liaison teachers, Education Training Board Adult Literacy and Community Education Coordinators and on social media.

### Healthy Homes Pilot

Longford is one of nine counties taking part in a two-year Healthy Homes pilot. It aims to ensure older people are supported to continue living in their own homes and communities. A Healthy Homes Coordinator started in May to support this programme.

### Creative Ireland Longford

Many online and live events took place under the Creative Ireland Longford programme, including the Cruinniú na nÓg festival, Still Voices Short Film Festival and Longford Memories launch.

The annual Cruinniú na nÓg festival celebrated the creativity of children and young people in June. A family passport to County Longford's 24 playgrounds and parks initiative was launched in Ballymahon.

The Still Voices Short Film Festival in Ballymahon featured 150 short films. It included the work of award-winning international film director Terence Davies, who attended the event.

Longford Memories: Reflections in a time of Pandemic launched in December. Created by former picture editor for the Irish Independent, Brian Farrell, it features interviews and photographs from 30 older Longford citizens. The book is now in its second print run.

### Longford Live and Local and Faoin Spéir

Longford Live and Local and Faoin Spéir events were enjoyed by almost 6,000 people with 49 events held across County Longford. Over 119 musicians were employed.

Funded by the Department of Tourism, Gaeltacht, Arts, Sports and Media, Longford had one of the largest and most diverse summer programmes of outdoor events in the country. The programme culminated in the largest attendance at a County Longford Culture Night.

The winter version of Longford Live and Local launched in November. For this, Longford County Council was awarded €143,000 to engage local creatives for events around the county. Over 61 events took place. It was coordinated by Creative Ireland Longford and local company Republic of Culture.







#### Bealtaine Festival

The Bealtaine festival which celebrates creativity and resilience in older people took place in May. Many online events took place, as well as 10 concerts in nursing homes and day care facilities over five days. Longford soprano Emer Barry took part.

### Positive Ageing Information Day

Positive Ageing Information Day took place in November with 95 older persons attending. Longford County Council, the Health Service Executive, An Garda Síochána, Longford Community Resources CLG, Alone, and Age and Opportunity all contributed.

#### **Archives**

#### Jude Flynn Collection Digitisation

The Jude Flynn Collection, which consists of 524 cassettes, were sorted, and listed, with its digitisation commissioned. The collection spans from 1983-2020 and is the most important oral history collection in County Longford.

#### Commemoration of the centenary of the destruction of Custom House

The Council Archivist took part in the 'People, Place and Power: Grand Jury Records and Local History' webinar to commemorate the centenary of the destruction of Custom House. It was organised by Beyond 2022, local government archivists and records managers.

### The Decade of Centenaries programme

# Library, Cultural, Heritage and Archives

#### The Robert McNally Project

The Council Archivist was involved in The Robert McNally Project. This project is led by University of Tasmania Professor Pam Sharpe. The project involves producing edited version of the journals (c. 1815-37) of a Longford soldier named Robert McNally. These are unique sources for the history of Van Diemen's Land, now called Tasmania.

#### Tourism projects

The Council Archivist worked with Longford Tourism and Heritage Office for the EZxploring project, as well as work for The Farrell Clan.

# Heritage

# County Longford Heritage Plan 2019-2024

In 2021, support for County Longford Heritage Plan 2019-24 projects was received from The Heritage Council and the National Biodiversity Action Plan Fund.

# County Longford Wetlands Survey 2021

County Longford Wetlands Survey 2021, which is an annual survey of non-designated wetland sites to access their potential biodiversity value continued. This year, Heritage worked with the Local Authority Waters Programme and the water scientist for the Midland and Eastern Region, who recently completed their water survey of the River Camlin. It was decided to concentrate on areas surrounding the River Camlin to give a more holistic overview of the area.

Overall the condition of the wetlands surveyed were good. Two sites were deemed to have 'countywide conservation value'.

# World Wetlands Day 2021

World Wetlands Day 2021 was promoted by highlighting wetlands within 5K of County Longford towns and villages. This complied with COVID-19 restrictions which were in place at the time.

# Biodiversity Week and Heritage Week

Wetlands Surveys Ireland developed a video introduction to wetlands for Biodiversity Week and undertook a live talk on the surveys for Heritage Week 2021.

# Library, Cultural, Heritage and Archives

#### County Longford Education Heritage Project 2021

County Longford Education Heritage Project aimed to develop engagement and awareness of education heritage by working with community heritage groups. This included:

- Work with a research committee at the Latin School Visitor Centre in Moyne to develop a schools information pack to promote engagement with an exhibition
- A virtual tour of mythical Brí Leith, working with Harp Media and Brendan Farrell
- Support for The Swinging Sixties publication by Paddy Egan
- Support for the Maria Edgeworth Centre Ambassador Programme. For this, two third-level students worked within the centre
- Biodiversity Week video presentations by Wetlands Surveys Ireland
- A built heritage conservation grants webinar with former conservation grant applicants Jane Meade Architect and Sweeney Architects

#### County Longford Popular Music Research Project

With funding from the Heritage Council, the Longford Popular Music Heritage Project was established in 2021. This project seeks to develop database of County Longford music bands, musicians, and venues. This project will continue into 2022.

Conservation of Plaster Oliver Goldsmith Statue at Pallas by John Henry Foley

County Heritage Plan funding was sought for an assessment of the nature and condition of the Oliver Goldsmith statue at Pallas More, Ballymahon. This statue is by eminent Dublin-born Victorian sculptor, John Henry Foley. It is a plaster version of the bronze sculpture of Oliver Goldsmith at Trinity College Dublin. In 1974, on the bicentenary of Goldsmith's birth, the statue was erected at the site of the old rectory at Pallas More, his childhood home.

A review of press coverage of the bicentenary showed that the statue was likely to be from Foley's studio and much older than previously thought. It was also uncovered that it was originally on display in the Round Room of the Mansion House, overlooking the First Dáil in 1919. Scientific testing, including x-rays and 3-D scans, were undertaken. Recommendations have been made for its repair.

# Heritage Week 2021

Heritage Week 2021 had a mix of online and in-person events. Events included:

- Restoring the Balance online series by Scéalta Beo. This won the County Award in the National Heritage Week Awards 2021.
- Videos on 'Surnames of County Longford' with Aidan O'Hara; 'Breeding Birds of Ardagullion Bog' with Birdwatch Ireland, a virtual tour of Ardagh with Ardagh Tidy Towns.
- The Longford Soldiers of World War 2 online event with Hugh Farrell
- Making your space swift friendly online event with Lynda Huxley, Swift Conservation Ireland
- 'Explore St John's Church, Longford' video by Harp Media, with Church of Ireland Longford Group of Parishes. This was broadcast on Culture Night.
- Norman People event at Knights and Conquests in Granard. It featured medieval life re-enactments, falconry display, traditional foods, and crafts

# Library, Cultural, Heritage and Archives

- Exploring public art workshops in Longford and Ballymahon, with EZxploring
- Readings on the Camlin with author John Connell to celebrate Water Heritage Day
- A walking tour of Ballinalee with Fr Tom Murray and Bernard Sexton with Longford Decade of Centenaries

#### Conservation Grants

The Built Heritage Investment Scheme 2021 allocated €77,000 for essential conservation repairs of ten protected structures.

The Historic Structures Fund 2021 allocation of €70,000 supported three structures in County Longford. Work included repairs to the 'Longford' gate house at Carrickglass, Creevaghmore House near Ballymahon and St. Mel's College, Longford. Additional funding from private investment and other funding was also secured for works.

The Community Monuments Fund 2021 allocation of €70,000 under stream one. This enabled emergency conservation repair works at the tower house to Abbeyshrule Abbey. €13,000 under the second stream of the fund allowed a non-invasive archaeological assessment and conservation management report on Rossduff Castle, near Aughnacliffe to take place. This funding was applied for by the Three Provinces Heritage Group.

# **Human Resources**

#### Recruitment and selection

As of 31 December 2021, Longford County Council had 377 employees. Throughout 2021, there were:

- 41 competitions advertised
- 691 applications received
- 49 interview days
- 30 interview boards
- 39 job appointment
- 11 promotions

# Transition to People XD Version 28

This Transition to People XD Version 28 took place in 2021. This portal is more user-friendly and accessible. It is used by our employees to record attendance, access payslips and pension details and view training records.

# Performance Management and Development

Helped by the Institute of Public Administration and the Council's IT section, an electronic performance management and development system (ePMDS) is now in place. ePMDS helps with the management of performance and helps build capacity through learning and development. In 2021, 214 employees attended ePMDS workshops and training.

# Learning and Development

The Council enables continuous and lifelong learning. Training for 25 different competencies were delivered in 2021, for which 1232 people attended. This includes climate action training for 304 employees, and health and safety training for 373 attendees.

# Open Learning Scheme

23 employees participated in Longford County Council's Open Learning Scheme for the 2021/22 academic year. The scheme supports employees who wish to undertake studies in further education building capacity across the organisation.

# Health and Wellbeing

60 programmes were delivered to 720 employees through the health and wellbeing programme. In June, 89 employees availed of health screening. In September, 94 employees availed of blood pressure reading. The influenza vaccination was given to 72 employees in November. In May, the Longford County Council Choir took part in in IBEC Workplace Choir of the Year online competition

# **Information Technology**

# Longford Connected Communities Officially Launched

Longford Connected Communities was officially launched in June. Eight Broadband Connection Points (BCPs) now provide high-speed broadband to rural communities and help remote working across Longford. The BCPs also host events for the community, including a Talking Art Online class with the Irish Museum of Modern Art.



#### Connected Hubs Call 2021

Funding of €234,677.84 was secured for four Broadband Connection Points (BCPs) and co:worx Edgeworthstown. The funding was used for upgrades, providing additional functionality, privacy and improved equipment. Funding was applied for with the Regeneration team.

# Longford Text Alert

Longford Text Alert project was awarded €14,000 under the Our Rural Future: Digital Innovation Programme 2021. This smartphone app will unify community communications across County Longford. It will update users on crime prevention and safety initiatives, community-led initiatives, including from Tidy Towns groups and activities happening in loca BCPs. The app will be launched in 2022.

# Council Meetings and Remote Working Support

Use of Microsoft (MS) Teams increased throughout the Council due to ongoing COVID-19 restrictions in 2021. Use of MS Teams was championed and supported by IT, facilitating remote working and a blended approach to meetings, including Council meetings. This work included updating security protocols to ensure confidentiality, integrity and availability of remote workings solutions.

#### Meet and Code 2021

Funding was secured under Meet and Code 2021 for two coding events which took place in Bridgeways Family Resource Centre, Ballymahon and St Colmcille's National School in Aughnacliffe.

# **Information Technology**

# Longford County Council Digital Strategy: Centred and Connected

The Council's first Digital Strategy: Centred & Connected was approved in September. At the National Oversite and Auditing Committee's annual Good Practice in Local Government seminar, IT and the Regeneration team presented a case study on this strategy. Information on the Broadband Connection Point network and the Rural Working Hub Strategy was also presented.





# Network Infrastructure Upgrades

A new hybrid cloud Information and Communication Technology (ICT) architecture was implemented in 2021. This allows the Council to move towards more innovative work processes and practices which are scalable, adjusting for additional demands for computing resources, if required.

# IT Helpdesk

5,994 Information Technology (IT) helpdesk issues were resolved in 2021.

# Applications

Many application (app) projects were progressed in 2021. These include:

- mobile housing inspections app
- electronic Performance Management and Development System (ePMDS)
- eService Plan
- County Longford walking trails and playgrounds. This included the mapping of these trials using IT's geographic information system (GIS)
- GIS web application development and enhancement to facilitate spatial data collection and analysis
- Longford County Council property register map application
- Community Activities Fund. Submissions to this fund were through a web-based app, with processing of submission all done electronically


# Website accessibility

Council websites now have accessibility software which provides text-to-speech and translation options and assistive technology for people with disabilities.

# Rural Working Hub Strategy

Longford County Council is the first Irish local authority to develop a Rural Working Hub Strategy specific to the needs of the local community. It addresses need of people who commute to outside of County Longford for work by aiming to provide opportunity to work within the local communities. Through this, workers bolster economic activity within their local County Longford communities.

The Strategy and Guidance Document on Rural Working Hubs was shortlisted for the Local Authority Innovation category at the Chambers Ireland Excellence in Local Government Awards 2021. It was also nominated for the Economy category of the European Innovation in Politics Awards 2021.









# Connected Hubs Call 2021

Regeneration worked with the Council's Information Technology section and local community committees to set up Broadband Connection Points (BCPs) under the Connected Hubs Call 2021. BCPs offer high-speed broadband to communities with poor connectivity. They are located in Abbeyshrule, Aughnacliffe, Ardagh, Carrickedmond, Corlea, Granard, Moyne and Mullinalaghta. Some of these spaces offer remote working facilities.

# Regeneration strategies for Granard and Lanesborough-Ballyleague

Regeneration strategies were prepared for Granard and Lanesborough-Ballyleague. These strategies contain short, medium and long-term paths to enterprise and job creation. They build on existing and planned investment and innovation initiatives. Further work will be undertaken by Regeneration to delivery of the actions in these strategies in 2022.

# Camlin Quarter Regeneration

Camlin Quarter Regeneration project in Longford town was awarded €10.4m under the Urban Regeneration and Development Fund (URDF). Additional funding of nearly €14m was provided by the Irish Government and Longford County Council. Together with the €4m Longford Connected project, it will transform Longford Town's centre, increasing footfall, improving the commercial environment and attracting future investment.





# Pobal le Cheile, Ballymahon

€6.6m was secured the Pobal le Cheile, Ballymahon project. This involves renovating three historic town centre buildings: a former convent building, an old boys school and the former Dean Egan Library. They will be transformed into a coworking space, a youth hub and a community centre. This will provide key services for the local community and have a significant and sustainable impact on social and economic development.

# Granard Motte Project

€3.5m in funding from the RRDF and Fáilte Ireland secured in 2021 will be used for Granard Motte Project. This will lead to the creation of a Norman heritage park at Granard Motte. Working with the Granard Motte Community Enterprises Limited and the consultants, work on this project progressed throughout the year.

# Longford Connected

Works on the progressed €4m URDF project in Longford town in 2021. This project will improve the accessibility, appearance and walkability between Albert Reynolds Peace Park, St Michael's Boys National School, Longford Shopping Centre and St Mel's Cathedral. The construction contract for the public realm at Longford Shopping Centre and Market Square was awarded in November, with work expected to start in quarter two of 2022.

# Red Bridge Ballymahon

Working with Waterways Ireland, the Red Bridge, Ballymahon project was completed in October. For this, a floating jetty at the Red Bridge on the River Inny at Shrule was installed. A car park and solar powered lighting was also put in place. This is an example of a Regeneration project to develop and enhance waterside amenities.





# Royal Canal Spur Gateway Project

Royal Canal Spur Gateway project will lead to enhanced connectivity between Longford Town and the Royal Canal Greenway. It includes improved walking and cycling facilities from Market Square to the greenway, as well as a multi-use urban space located on the former harbour. Detailed design was finalised in 2021. Construction tender documents are being prepared and work is expected to start in quarter two of 2022.

# Enhancement and Attractiveness of Lanesborough as a Tourism Destination

Under the Enhancement and attractiveness of Lanesborough as a Tourism Destination project, funding was acquired, and consultants appointed for design and environmental assessments for an amphitheatre, visitor centre and link road in Lanesborough. This will reposition Lanesborough as a tourism destination within Ireland's Hidden Heartlands. This project will be progressed in 2022.

# Mid-Shannon Wilderness Park Greenway

Work continued throughout 2021 on the construction of the Mid-Shannon Wilderness Park Greenway. This work creates a loop through the bogs which links back into the Royal Canal Greenway. It will ultimately link the Royal Canal Greenway at Clondra with Lanesborough.

# The Yard Hub project in Abbeyshrule

In November, work started on the Yard Hub project in Abbeyshrule. This involves redeveloping a derelict site to create space for economic activity. Offering offices and coworking spaces, it will give local people the opportunity to work close to home. It will also be the new home to Abbeyshrule Canoe Club.



# **URBACT UrbSecurity**

Regeneration, recognising the issue of urban security, are now involved in UrbSecurity under the URBACT programme. Working with project partners, UrbSecurity aims to plan safer urban spaces. For this, the group will analyse urban design and planning strategies and concepts that prevent anti-social behaviour and improve quality of life for citizens. An integrated action plan for each project partner is aimed for. The project includes Madrid (Spain), Parma (Italy), Pella (Greece) and Longford. This work also allows for the promotion of the Council's work on a European stage.

# Keenagh Village Enhancement

Drafted by Keenagh and District Development Association, the final part of the Village Enhancement Plan was completed in 2021. New cast iron poles and energy efficient lighting has greatly enhances the village streetscape. They also added to other projects under the plan, including the new community playground, and new walkways and cycleways along the Royal Canal, as well as in the Corlea Bog and around the village itself. The plan has contributed to increased visitors to the area.

#### **Unfinished Estates**

Work continues to ensure all estates are of a sufficient standard to ensure enhanced quality of life for residents. There were originally 128 unfinished estates within County Longford. As of November, there are eight sites remaining to be taken in charge by the Council. Site resolution plans for these remaining estates were negotiated and work will continue in 2022.

# Outdoor Recreational Infrastructure Scheme funding

Under the Outdoor Recreational Infrastructure Scheme (ORIS) funding of €651,830.94 for ten projects was announced in 2021. This includes the following projects:

- North Longford Rebel Trail Granard Greenway (funding of €200,000)
- Royal Canal Greenway car park at Stonepark (funding of €20,000)
- Aughnacliffe amenity trail enhancements (funding of €20,000)
- Lime Tree walk in Keenagh (funding of €20,000)
- Derrycassin Woods enhancement (funding of €20,000)

# Housing

#### Maintenance and Refurbishment

€1,493,302 was provided in the Council 2021 Budget for the maintenance and repair of Council properties. Despite COVID-19 restrictions, efforts were made to carry out as many repairs as possible throughout 2021. More than 2,300 repair requests were responded to in 2021. Pre-letting repairs were also completed on 52 properties. These repairs allowed these properties to be brought up to a high standard ahead of new tenants moving in.

# **Energy Retrofitting Scheme**

Under the Energy Retrofitting Scheme, €3.3m was allocated to the Council for the retrofitting of local authority-owned houses. Retrofitting work started on 70 properties, with 24 completed by the end of 2021.

Condition surveys identified the work needed to bring an additional 89 properties up to the required standards. Retrofitting will reduce energy costs for these properties, while making them warmer and more comfortable to live in.





# Housing Grant Schemes

To meet the needs of people with accessibility issues, 156 housing grants valued at €875,394 were approved across the three categories:

- Mobility Aids: €185,538 awarded
- Housing Adaptation: €342,588 awarded
- Housing Aid for Older People: €347,268 awarded.

In addition, work costing €243,398 was carried out on 24 Council-owned properties to improve accessibility. This work included making bathrooms accessible, installation of stair lifts and specialised equipment to accommodate the needs of individuals. This work greatly improved the quality of life of people living in these properties and in many cases allowed these individuals to continue to live outside of care settings.

# Private Rented Property Inspections

The Council conducted 331 Private Rented Property Inspections in 2021. These inspections help to enforce standards in the private rental sector. Unfortunately, due to COVID-19 restrictions, the target for inspections (570) could not be met in 2021.

# Housing

# Social Housing Support

Social housing support is provided to people who are assessed as being unable to afford housing from their own resources. From the Approved Housing List, 267 tenancies were allocated social housing in 2021. Social housing was obtained through various options including:

- tenancy of a Council property
- Rental Accommodation Scheme leases
- long-term social housing leases
- housing provided by approved housing bodies
- Housing Assistance Payment

There were 828 applicants on the Approved Housing List on 31 December 2021.

In 2021, the numbers of units that were provided to first-time tenancies were:

- Second-hand property acquisitions: 15
- Social Housing Leases: 17
- Turnkey New Build Properties: 69
- Rental Accommodation Scheme Leases: 6
- Housing Assistance Payment Leases: 80

The output figures represent the continued commitment of the Council to delivering for those on the Approved Housing List.

During 2021, a number of Approved Housing Bodies that had not previously worked in County Longford expressed an interest in doing so and efforts will be made to build relationships with some of these in 2022.

#### Traveller Accommodation

The Longford Traveller Accommodation Plan 2020-2024 was adopted by the Council in 2021. The includes agreed targets for the number and type of accommodation to be provided.

The Local Traveller Accommodation Consultative Committee worked on progressing the development of a Traveller accommodation group housing project within the lifetime of the newly-adopted Traveller Accommodation Plan. Training and focus group discussions were also conducted to determine how to better address the needs of the Traveller community.

#### Homelessness

Homelessness is dealt with on a collaborative basis in the Midlands. Westmeath County Council is the lead agency, in partnership with Longford, Laois and Offaly County Councils. Advice and assistance are provided to those who present as homeless to Longford County Council. 87 people presented as homeless in 2021.

# **Planning**

# County Development Plan

The County Development Plan 2021-27 was adopted by the Elected Members in October 2021 and came into effect in November 2021. This sets the planning framework for development in the county.

The recently-established Office of Planning Regulator assessed and made recommendations on the plans as prepared by the Planning Authority. Similar input is expected when the Town Plan will be prepared in 2022.

In addition, the Forward Planning Section is regularly involved with other projects that require substantial time allocation such as Compulsory Purchase Orders (CPOs), Route Corridor Studies and other projects from national to local level.

# Planning Applications

Planning applications in 2021 covered a mix of developments, including residential, agricultural, retail, amenity and employment. The following number are application statistics in relation for 2021:

# Part 8 Planning

Part 8 Planning is a reference to Part 8 of the Planning and Development Regulations 2001, which sets out the procedure for carrying out certain Local Authority developments. Such works would include developments such as the construction of houses, roads, public amenities and more. In 2021, the following Part 8 applications were advertised and adopted:

Pre-planning consultations are integral to development management process, providing an informative and transparent planning service to the general public. Planning held numerous pre-planning consultations in 2021. During COVID-19 restrictions, Planning also increased its online activities to maintain a consistent service including facilitating pre-planning meetings and availability of documents online.

# Development Contributions Scheme 2018-2022

Development Contributions Scheme 2018-2022 had a positive impact on the delivery of infrastructure in County Longford since its introduction. It has generated funds for infrastructure, include the acquisition of land, provision of open spaces, recreational and community facilities, roads, carparks and footpaths. The implementation of a new debt management system to manage the Development Contributions Scheme has led to improved customer service and audit and tracking of the scheme.

# **Planning**

# Forward Planning

The Forward Planning team is responsible for researching, preparing and producing all development plans, local area plans and other forward-looking initiatives.

Forward Planning contribute to national and regional planning, with employees attending national and regional planning working groups. Submissions were made by the Forward Planning team to national and regional guidance documents in 2021, as part of this work.

# National Housing Policy

Planning works closely with the Council's Housing section to identify suitable land for development under the new Housing for All policy. This work includes site assessments and layout design for sites to determine its potential for housing developments.

# Tourism, Community and Regeneration Initiatives

Planning worked with Regeneration, Fáilte Ireland, Longford County Council's Tourism Committee, Local Enterprise Office Longford, Elected Members and community groups on tourism, community and regenerations initiatives in 2021. These include the:

- Mid Shannon Wilderness Plan Lough Ree UNESCO Biosphere Reserve, in partnership with the National Parks and Wildlife Service, and Roscommon and Westmeath County Councils
- Walking trails at Newcastle Wood, in association with Coillte
- Mid Shannon Wilderness Walks and Corlea Trackway Biodiversity Park, in association with Bord na Mona.

# Planning Enforcement

The Planning Enforcement team continue to investigates public complaints regarding unauthorised developments and non-compliance with planning permissions, taking legal proceeding, if necessary. The team have achieved success through negotiation and resolution at pre-warning letter stage, resulting in the minimisation of enforcement notices and legal proceedings.

A budget €13,789,810 was allocated for County Longford roads in 2021. Transport Infrastructure Ireland allocated €4,479,822 to Longford County Council for national roads in 2021. This included:

# Capital Maintenance Pavement Repairs

Capital Maintenance Pavement Repairs at N55 in Edgeworthstown, N55 at Ballymahon, N63 in Lanesborough and N4 Edercloon and Clooniher in County Longford. The Capital Maintenance Pavement Repairs, is the repairs of defects on National Roads with a value between €50,000 and €250,000, funded by Transport Infrastructure Ireland (TII).

# Restoration programme for regional and local roads

The Restoration programme improved 74.25km of regional and local through surface restoration and road reconstruction. The Restoration programme also helped to maintain 74.58km of regional and local roads by use of surface dressing to protect the structural integrity of the roads.

# National Road Pavement Improvement Schemes

National Road Pavement Improvement Schemes are selected on the basis of recent condition surveys of the network. The following works under this scheme were carried out in 2021:

- N4 at Newtownforbes: work includes footpath improvements, undergrounding of electricity wires and new public lighting
- N63 at Barnacor: resurfacing of 1.2km section between Lanesborough and Killashee
- N63 at Market Square: work includes improvements to footpaths, provision and improvements to pedestrian crossings
- N63 at Lanesborough: design and tendering for scheme. Works due to start in 2022.
- N63 at Majors Well Road: design and tender for scheme, with works started in November 2021. It
  includes reconstruction of 600m section approaching Longford Town, installing footpaths and cycle
  tracks, undergrounding of electricity wires and new public lighting





# Low-Cost Safety Improvement Grants

The Low-Cost Safety Improvement Grants enable low-cost safety improvement works on regional and local roads. Work under this scheme includes upgrading a pedestrian crossing at Ballymahon Primary School, signage and road markings from Lisduff Hill to Lisduff Cross and other works at Coolagherty, Derryoghil and Clooncallow.

# Local Improvement Schemes

In 2021, the Council was allocated €386,892.40 under the Local Improvement Schemes, with 14 of these schemes completed across the county. This scheme allows for non-Council roads to be repaired at a relatively-modest cost. It is funded by the Department of Rural and Community Development

# Public lighting

Of the 5729 public lights taken in charge by the Council, 3563 are now upgraded to LEDs. The Council will continue upgrading public lighting to LEDs in 2022.

# Climate Change Adaption and Rehabilitation

Under a Climate Change Adaption and Rehabilitation allocation, three projects were constructed:

- R198 road at Tawnagh: Embankment stabilised and widened with additional piped drains installed.
- Abbeylara Village: Installation of drainage system to collect runoff water from adjoining land and farmyard, this will alleviate flooding which was becoming more regular and pronounced.
- L-10070 road, Ballagh-Drumlish: Edge strengthening and road widening to help with the issues of trucks meeting one another. This work was especially important as this is the only diversion route available when the N4 is closed between Newtownforbes and Roosky.

# Community Involvement Schemes

Four approved schemes were completed under the Community Involvement Scheme in 2021. Three schemes were in the Granard MD-Soran, Esker, and Kiltycon, and one in the Longford MD Kilnashee, Drumlish.

#### **Active Travel**

In 2021, the Council were allocated over €2m from the National Transport Authority for Active Travel schemes. For this, an Active Travel Team was recruited to manage a multi-annual Active Travel Investment Programme for developing walking and cycling infrastructure in County Longford. Active travel works undertaken in 2021 include:

- R198 Battery Road Longford: Designs for a pedestrian and cycle scheme
- Harbour Row-Killashee Road: Designs for junction improvement and footpath scheme
- St Matthews National School, Ballymahon: Part-funding of new pedestrian crossing
- N63 Ballinalee Road: Preliminary designs for pedestrian and cycle scheme
- Ennybegs village to St Teresa's National School, Ennybegs: Preliminary designs for footpath
- Templemichael College in Longford Town and at Scoil Mhuire National School in Newtownforbes: Preliminary engagement with Green Schools and An Taisce to deliver safe routes to schools schemes

# Road Safety

Longford Road Safety Working Together Committee includes the members of the Transport Infrastructure Ireland, the Road Safety Authority, An Garda Síochána, as well as the Council's Road Safety Officer, the Council's Sports Coordinator, a Longford Fire Service representative and a member of Longford County Childcare.

The committee met in May 2021 and discussed items relating to road safety under the four key pillars, of Education, Engineering, Enforcement and Evaluation. Actions were agreed. The committee is to meet again in 2022 to prepare a Local Road Safety Strategy, when the National Government Road Safety Strategy is launched and finalised nationally for local adoption.

Longford County Council is also one of 11 local authorities that took part the Tik Tok Road Safety Campaign which was run in partnership with the Local Road Safety Officers Group and iRadio. It won a Silver award for Best Digital and Social Innovation Campaign at the Investment Management Regulatory Organisatio (IMRO) Radio Awards for 2021.

Due to COVID-19 restrictions, the AXA Road Safe Roadshow which aims to promote road safety among young road users was unable to be delivered locally in 2021. Instead, four local schools, capturing 275 transition year students and teachers, signed up to a live national presentation on 22 April, in conjunction with Mayo County Council, emergency services and AXA Insurance. It was organised in conjunction with the Longford County Council Road Safety Officer.

Roads helped to promote several road safety campaigns including Road Safety Week in October by engaging with local primary schools and running road safety competitions. Roads also promoted National Slow Down Day, with is run with An Garda Síochána. World Remembrance Day for road traffic victims in November was also marked by the Roads section.

#### Bike Week 2021

Roads participated in Bike Week in September, along with the RSA and Longford Local Sports Partnership. A Play it Safe programme was delivered to local schools, high-visibility vests were distributed to schools also, as well as to sports clubs.

# Parking Fines

1188 fixed charge offence notices or 'parking fines' were issued by the Council in 2021. These fines help to tackle careless or illegal parking. 285 fines were also issued for non-display of tax.

# Parking Permits

The Council issued 69 quarterly permits for off-street car parks, 53 resident permits, four over-65s permits and 265 Longford County Council employee carpark permits.

# Water

# Water Services Budget

In 2021, Longford County Council Water section had an annual operations budget of €6.2m and capital spend of €1,293,917.

#### Annual Service Plan

The Annual Service Plan sets out targets covering water quality, wastewater, expenditure, procurement, achieving efficiencies, value for money and more. Assisting against these targets, Water Services ensured that all water supply zones operated at maximum efficiency levels.

# Irish Water Service Level Agreement Key Performance Indicators

The Council's Water section scored highly against Irish Water Service Level Agreement Key Performance Indicators (KPIs). These KPIs measure performance of all local authority and indicates that, in County Longford, all water supply zones operated at maximum efficiency levels. The scoring for each quarter of 2021 is as follows:

# Find and Fix Programme

The Find and Fix Programme continued to repair leaks in the water network throughout 2021. It achieved the following water savings:

- Rathcline Road in Lanesborough: 192,000 litres per day
- Lanesborough area: 288,000 litres per day
- Whitehill and Granard area: 110,400 litres per day
- Whitehill and Ballymakeegan: 62,800 litres per day
- Ballymakeegan area: 78,000 litres per day
- Moydow area: 86,000 litres per day
- Foygh area: 70,000 litres per day
- Cornhill and Drumlish area: 58,000 litres per day





# Water

# Capital Network Upgrade Schemes

Capital network upgrade schemes, which were deemed to be essential activities, continued. This work includes the installation of new watermains to improve the water network and increase security of supply. Capital network schemes were completed at Ballymakeegan, Templemichael and Bannon Terrace, Clonboney and Rathcline Road in Lanesborough, Creevy in Granard, and Cahanagh-Pucklish in Ballinamuck.

# Early Contractor Involvement Works

The Early Contractor Involvement Works is a national programme aimed at carrying out improvement works at water treatment plants to ensure the continued delivery of safe drinking water. In 2021, Early Contractor Involvement Works were progressed at:

- Lough Kinale (Granard)
- Lough Gowna (Smear)
- Lough Forbes (Longford Central)

# Water services during COVID-19

Water services are essential, and every effort was made to ensure the continuation of high-quality water and wastewater service during COVID-19. A Water Services Business Continuity Plan was implemented and worked well, with none of County Longford's water services compromised due to the pandemic. Water services wastewater team kept all treatment plants and networks operational to meet environmental standards throughout the year.

Strict operating procedures were implemented across all sites to protect employees. These procedures included social distancing, staggered working arrangements, increased hygiene requirements and the use of additional personal protection equipment.

# National Spring Clean

National Spring Clean 2021 and Longford's Green, Keep it Clean campaigns led to over 30 tonnes of waste being collected all over the county. As well as handing out litter pickers, gloves, bibs and bags, Longford County Council organised the collection of waste from across the county. Over 200 individuals and groups took part in these clean-ups.







# Waste and Litter Management and Enforcement

During 2021, 1781 waste and litter complaints were received and investigated, with 1,801 complaints resolved (this figure includes outstanding complaints from 2020).

Ten prosecutions for non-payment of litter fines were initiated in 2021. Fines and costs awarded by the courts to Longford County Council amounted to €5,790.

Environmental investigations into illegal dumping led to the removal of 77.14 tonnes of waste this year. Street sweeping and servicing of litter bins in towns and villages took place, costing €557,338 in 2021.

# Waste Management Provision of Facilities

There are 23 bring bank sites in County Longford. Green, brown and clear glass and aluminium cans are accepted at all sites. 962 tonnes of glass and 29 tonnes of aluminium cans were collected for reprocessing in 2021.

#### Anti-Litter Awareness Grants


The Anti-Litter Awareness Grant 2021 of €22,800 was divided between community groups, school workshops, anti-litter advertising and materials. Thirty local groups received €13,000 in funding for local litter projects.

# Anti-Dumping Initiative 2021

Longford County Council undertook two large clean-ups on fly-tipping black spots. 14.72 tonnes of waste was collected. This work was helped by local household waste surveys and awareness and preventative measures.

#### Waste Collections

One large goods collection and one hazardous waste collections were held in Longford during 2021. 8.56 tonnes of hazardous waste and 9.28 tonnes of general waste and recyclable materials was collected.







# Pollution Control and Water Quality Management

Under pollution control and water quality management legislation, 39 investigations of water pollution incidents and 22 farm inspections took place in 2021. Also this year, there were:

- Inspections relating to licenses for discharging to waters: 20
- Samples from small private and group water supplies: 33
- Monitoring activities occurred for rivers and lakes: 69
- Inspections of historic landfills: 10
- Septic tank inspections: 11

Environment also facilitates a catchment focus group which includes representatives from Department of Agriculture, Food and the Marine, Teagasc, the Environmental Protection Agency, Local Authorities Water Programme and other stakeholders. This group investigates causes of high levels of the acid herbicide MCPA in the Lough Forbes catchment area. This catchment area is the source of Longford's largest public water supply. This group met four times in 2021.

# River Basin Management

Catchment inspection work was coordinated with the national Local Authority Water Community Office. Extensive work was undertaken in the River Black (Ballinamuck) catchment area to improve water quality. The Council monitored water quality in rivers and lakes in line with the River Basin Management Plan for Ireland 2022-2027.

# Recommended Minimum Criteria for Environmental Inspections Plan

The Recommended Minimum Criteria for Environmental Inspections (RMCEI) Plan 2021 outlines correct procedures for environmental inspections. Mandatory reporting to the Environmental Protection Agency (EPA) is in place also. Environment must annually compile an inventory of all waste data for County Longford for submission to the EPA.

During 2021, the Council's routine waste inspections focused on three priority areas of waste, water and air. Areas and actions under these priorities included:

- Waste: tackling significant illegal waste activity, household and commercial waste collection, and tracking waste flows
- Water: farm inspections, monitoring private water supplies, bathing water monitoring, and septic tank inspections
- Air: compliance of solid fuel merchants, retailers and households, ambient air mointoring programme, and air and noise control complaints and planning

#### Energy

In 2021, the Council surpassed its target of a 33% reduction based on 2009 figures, achieving a 44% reduction. The Council is on course to meet its 2020 target of 30% reduction in energy usage.

#### National Tree Week

National Tree Week was organised by the Tree Council of Ireland and supported by Coillte and the Council. For this, community groups, Tidy Towns groups and other organisations plant young trees around their communities. Over 300 free saplings were given out to over 25 groups and 15 individuals.

#### Green Schools

During 2021 eight schools in County Longford renewed their Green Schools Green Flags. This recognised the work of these schools to tackle litter and waste, to improve energy and water conservation, and to raise awareness of the impact of travel, biodiversity and global citizenship. Environment helped schools with their applications, as well as by providing workshops, meetings and in person visits.

# Invasive Species

The treatment of Japanese Knotweed continued with €30,000 in funding granted for a countywide treatment programme along the county's road network. Over 320 sites have were treated, with 10 new sites identified during 2021. This work will continue in 2022.

# N4 Bypass and Roundabout Pollinator and Biodiversity project

The N4 Bypass and Roundabout Pollinator and Biodiversity project continued with four of the five roundabouts populated with pollinator-friendly perennial plants and flowers. Native Irish trees were also been planted on the roundabouts on the recommendation of Transport Infrastructure of Ireland.

# Veterinary

## Food Safety

There was a drop of 10% in the throughput of small slaughterhouses in County Longford. This compared to a 28% and 36% increase in 2019 and 2020, with the decrease in 2021 attributed to COVID-19 restrictions.

All owners and staff in small slaughterhouses in County Longford now have of Competence in Welfare certificates. Meat products produced in the county are under official veterinary controls.

Recently, a new Food Safety Official Controls, Regulation (EU)2019/625, was introduced. This regulation requires a proactive approach to preventing food fraud and deception.

#### Dog Control

The number of stray or unwanted dogs in 2021 was 122. This figure is part of a continued downward trend in stray or unwanted dogs since 2019 and indicates improvements in responsible dog ownership. Of those seized, three were re-homed, twenty were reclaimed by their owners and 107 were transferred to dog welfare groups.

There were five incidences of livestock worrying dealt with by the Council in 2021.

Inspections of dog breeding establishments continued in 2021 under the Dog Breeding Establishment Act. Additionally, a lot of work related to the control of restricted breeds of dogs, with the Council's Dog Control Service providing significant assistance to An Garda Síochána.

#### Horse Control

In 2021, 22 horses were seized in Longford under the Control of Horses Act 1996. This was a reduction of 33% on 2020 figures and a trend in the right direction.

Throughout the year, the Council cooperated with the Department of Agriculture, Food and the Marine on a plan for an Urban Horse Project.

The fourth Pony Riding and Animal Welfare project for training young people in responsible horse ownership. Longford Local Sports Partnership and Longford Community Resources Limited supported this education project for the young people in County Longford.





# **Fire Services**

# Inspections, Callouts, Certificates and Applications

Thirty-one fire safety inspections of commercial premises were carried out in 2021 and 339 callouts took place.

Twenty-three fire safety certificates, 43 planning applications and 15 court licence application referrals were assessed or processed in 2021.

# **Operational Costs**

Longford Fire Service cost €2,140,000 to operate for 2021. This is lower than previous years due to employee vacances and lower number of callouts this year.

#### Recruitment

Recruitment of firefighters is an ongoing issue. Three firefighters left Lanesborough fire brigade in 2021, with these posts remaining vacant.

# New Fire Engine

Contracts have been signed for the purchase of a new fire engine worth €340,000. Capital funding has been provided by the Department of Housing, Local Government and Heritage for this vehicle, with its expected delivery in quarter two of 2023.

# Fire Fighter Training and Drill Programme

Fire Fighter Training and Drill Programme was completed in accordance with the Fire Service Annual Operational Plan 2021. All crew members in each Fire Station attended drill programmes, making up 40 drill nights in 2021.

The other training carried out includes courses on breathing apparatus, compartment fire behaviour, road traffic collisions, aerial ladder platform instructor and operator courses, and chainsaw operation.





# **Civil Services**

#### **Duties and Tasks**

Longford Civil Defence completed 63 duties and tasks in 2021 including:

- 19 COVID-19 related tasks, which made up 163 volunteer hours. This included transport for vulnerable persons for vaccinations, delivery of supplies on behalf of Longford libraries and administration duties at the HSE walk in COVID-19 test centre.
- 25 sporting events equalling 393 volunteer hours, including Longford Town Football Club soccer matches, as well as GAA matches and athletics events.
- 19 community events equalling 261 volunteer hours, including Longford Live and Local, the Carrick Camino, assistance with the Irish Blood Transfusion service
- 817 volunteer hours were provided to the community

## Training

Training was completed online, outdoors or with reduced numbers in order to adapt successful to adapt to COVID-19 restrictions. Training carried out includes courses on first aid response, Tusla child protection, approved driving instructor training, water and flood awareness, and critical incident stress management

Training was also provided to County Longford community and voluntary groups. This includes cardiac first responder training provided to Longford Town Football Club stewards and coaches. An online first aid information session was presented to Longford Women's Link's Migrant Women's Group. A first aid demonstration was also delivered to Ardagh Brownies and Girl Guides at an international camp.

An emergency medical technician's portfolio was assessed by the pre-hospital emergency care council (PHECC). An EMT portfolio is required to be completed annually for retention of a practitioner licence.

# Equipment and vehicle purchase

A communications unit was purchased with grant funding from the Department of Defence. This vehicle will be used for major emergencies, missing person searches and in larger duties. The vehicle will be ready to add to the fleet in 2022.

A Mitsubishi L200 4X4 was purchased after successful application to the Dormant Account Fund. This vehicle will be used to assist in severe weather events.

A Department of Defence grant helped to purchase equipment for mapping, online training and furniture for Civil Defence headquarters.

This is the seventh consecutive year the Council have won an NISO award. ISO 45001:2018 Accreditation of Council's Safety Management System with an extended remit for the accreditation secured – Corporate Services

Ensured consistent enforcement of our powers under various Environmental legislation – Environment

Since 1 January 2021, 76 approaches by homeless persons have been dealt with in the Housing Department. The provision of emergency accommodation for these 21 individuals over a total of 1,537 bed-nights so far in 2021 has cost €90,606.00 − Housing

Road safety improvement works to the value of €265,500 at various locations throughout the county – Roads

The Fire Service helped to support and maintain safe, sustainable and active communities in our county by maintaining the current operational Fire Service throughout the pandemic – Fire

The Fire Service promoted and implemented best practice in Health and Safety through audits of work practices, procedures and documentation resulting in getting ISO 45001 accreditation for our Safety Management System – Fire

The Fire Service partnered with other principal response agencies to plan and respond to emergencies by ensuring necessary planning, preparedness, capacity, training and coordination is in place – Fire

The early contractor involvement works is a nationally programmes aimed at carrying out improvement works at water treatment plants to ensure the continued delivery of safe drinking water – Water

Training for 17 health and safety competencies was delivered in 2021, catering for 373 employees – Human Resources

Funding received from the Department of Justice to establish a new Local Community Safety Partnership in Longford on a pilot basis – Community

Award grants of €43,000 through the Local Community Development Committee to support frontline organisations – Community

#### A County for Everyone

Communications Unit established with dedicated Communications Officer appointed in January. Strategic Communications Plan 2021-2024 was developed and approved in October 2021 as a framework to give strategic direction to all Council's communication activities — Corporate Services

Delivered environmental awareness and education strategies through Green Schools programme. Veterinary and Longford Local Sports Partnership developed a very successful Urban Horse-Riding Programme 2021 – Environment and Veterinary

To date in 2021 a total of 476 new Social Housing Support Applications have been received from individuals and families seeking to get onto the Council's Housing Waiting List. So far this year, a total of 647 Housing Applications have been either processed for the first time or have been reviewed – Housing

Successful Live and Local summer and winter programmes, funded by the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media. Longford Live and Local celebrated local artists and performers in summer 2021 with the return of outdoor performances marking a successful programme of events. A selection of over 50 local performers collaborated with almost 50 live events across nearly every town and village in the county, with talents both young and old getting a chance to perform again in front of a live audience. Almost 6,000 fans attended – LEO

Road and bridge improvement works were carried out throughout the county in both urban and rural areas enhancing physical connectivity throughout the county – Roads

The Fire Service support local democracy in our decision making by having a five-year operational plan in place which is adopted by our Councillors. This plan is reviewed on a yearly basis and an annual service operational plan is developed and implemented. The goals of this plan for 2021 are completed – Fire

Training for 25 different competencies was delivered during 2021, catering for 1,232 employees Twenty-three employees participated in the Open Learning Scheme for the 2021/2022 academic year. Sixty programmes were designed and delivered to 720 attendees through the health and wellbeing programme – HR

Continuing to host hybrid meetings to facilitate local governance during the changing COVID-19 restrictions – Information Technology

Successful rollout of Longford Live and Local, Faoin Spéir, Longford Age Friendly and Healthy Homes initiatives – Libraries

Success for Creative Ireland projects, Decades of Centauries programme in Archives section – Beyond 2022 – Library

Maximising engagement with the public in preparing the Draft County Development Plan ensuring the plan takes into account the wider communities' considerations and needs – Planning

Nine social inclusion projects approved for LEADER funding . Over €132,000 awarded to 76 organisations under the Community Enhancement Programme. – Community

Deliver and administer an investment of €413,283 allocated to date in 2021 for Community Sports Hubs, sports clubs, and sport and physical activity initiatives from various sources. 450 participants in walking programmes. – Community

Funding of €250,000 received under Healthy Communities Programme for works at Ballyminion

Over €300,000 Community Grant Support Scheme to support community groups through county-wide and Municipal District funding. Over €277,000 awarded to nine projects under the CLÁR scheme – Community

#### A Thriving County

In June the Council's Customer Services Charter was formally launched and implementation commenced Customer Relationship Management System introduction in November in Corporate Services – Corporate Services

A waste facility permit was issued for a site at Carrickboy quarry which can take up to 200,000 tonnes of soil and stone – Environment

Forty-two properties have been added to the Council's Social Housing Stock since 1 January 2021. Of these, two are Council constructed new properties and 23 are second-hand properties that were acquired by the Council and refurbished before being allocated to families on the Council's housing waiting list. A further 17 new properties, that were delivered via turnkey contracts, were also added to the Council's social housing stock and are now occupied. Work is ongoing on a number of other acquisitions and developments and it is hoped that a substantial number of additional properties will be added to the Council's social housing stock before the end of the year – Housing

Longford was allocated €236,800 under the Streetscape Enhancement Scheme run by the Department of Rural and Community Development, as part of the Our Rural Future development policy. This scheme encouraged business owners to upgrade and enhance the business properties in four selected town in the county: Longford Town, Granard, Lanesborough and Drumlish – Local Enterprise Office, Longford

Local Enterprise Office, Longford delivered this scheme on behalf of Fáilte Ireland encouraging hospitality businesses to enhance their properties promoting opportunities for outdoor dining. This allowed them to continue to trade but also enhanced the streetscape and the visitor experience. A fund of €165,000 was administered under this scheme to 48 businesses spread across the whole county − Local Enterprise Office, Longford

Major pavement schemes were completed in Longford Town on the N63 from Market Square, south to the roundabout, on the N63 at Barnacor and on the N4 in Newtownforbes. Ongoing design of future minor improvement work schemes on the N4, N5, N63 and N55 – Roads

Notable achievements delivered in 2021 included regional and local road improvement works to a value in excess of €4,240,500. Restoration maintenance works (surface dressing) to a value in excess of €1,216,500. LIS Funding of €393,041 received – 14 schemes completed. Drainage works to the value of €332,089 were carried out at various locations throughout the county. Community involvement schemes to the value of €101,561 were undertaken – Roads

Longford County Council in partnership with Irish Water progressed the installation of new watermains to replace older problematic mains in a number of locations to improve the water network and increase security of supply to those areas. Capital network schemes were completed at Ballymakeegan, Templemichael and Bannon Terrace, Clonboney, Lanesborough, Cahanagh-Pucklish – Water

Competitions advertised numbered 41,691 applications were recieved, 49 interview days were held, 31 interview boards were set up, nine temporary and 29 permanent promtions took place, ten employees retired and 14 employees resigned – Human Resources

In partnership with the IPA and the Information Technology section, an electronic performance management and development system was created to assist with the delivery of the objectives of the Corporate Plan. This put in place structures for the management of performance, build capacity through learning and development and to assist employees with their health and wellbeing. A total of 177 employees have attended workshops, training and coaching sessions during 2021 – Human Resources

Implemented a new hyperconverged infrastructure solution to provide a highly-available and robust Information Technology infrastructure for the Council's suite of services – Information Technology

Launched the Longford Digital Strategy. A key part of which was the successful roll out free public WIFI in three towns, which has averaged 1,200 returning users each month. There was also the successful rollout of the Broadband Connection Point (BCP) network with more than 400 connections up to 31 October 2021. Secured funding of almost €250,000 under the Connected Hubs Call to upgrade four of the Longford's eight BCPs, as well as the co:work digital hub in Edgeworthstown − Information Technology

Edgeworthstown Community Library, a long awaited new community library and civic space for the town was opened to the public on Monday 22 November. This project will be the focal point for the regeneration of the whole town – Library

County Development Plan process completed and adopted setting out the policy to allow for the sustainable growth of Longford as a county – Planning

Due to the timely completion of the AFS, Longford County Council was the first in the country to have an audit completed for the second consecutive year — Finance

Record revenue expenditure budget of €61.2m for 2022 - Finance

Restart Grants for 664 ratepayers worth €1.97m and Restart Grants Plus for 672 ratepayers worth €4.23m; 'wet pub' top ups to 80 pubs worth €280,000; Small Business Assistance Scheme for COVID to 82 ratepayers worth €280,000; rates waivers worth €2.62m was processed for 623 ratepayers for Q3 year-to-date and €464,000 for Q4; €59,000 collected on fire charges in 2021 year-to-date versus €15k,000 collected in 2020 (full year). €1.3M compensation secured for Lanesborough Power Station Rates 2022. Twelve projects approved for LEADER funding — Community

In 2021, the Regeneration team submitted 27 applications for funding to central government under a number of funding streams, of which 13 were successful. Awaiting announcements on a further 14 submissions totalling €2,978,903.81. As of November 2021, the Regeneration team are working on projects totalling €43.6 million which have been completed or are ongoing in 2021/2022.

#### A Greener County

Longford County Council succeeded in reducing our energy consumption resulting in a 44% reduction based on 2009 baseline, thereby exceeding the governments targets – Environment

Funding of €4,231,933 has been allocated to the Council for the retrofitting of some of its social housing properties. This funding has been allocated from the Midlands Energy Retrofitting Programme (Just Transition Fund) and the Energy Efficiency Retrofitting Programme. Work on the retrofitting of an initial tranche of 159 Council social houses has already commenced – Housing

Local Enterprise Office, Longford led a Going Green pilot programme in 2021 where 32 participant businesses across the Midlands worked with environmental consultants to investigate ways their business might become more environmentally sustainable. A programme budget of €220,000 allowed for a grant of €5,000 per company which was used to introduce a green solution to each business identified during the audit process – Local Enterprise Office, Longford

Construction of climate change adaption schemes totalling €249,250 in 2021. Formation of an active travel Team and delivery of active travel projects throughout the county. Continued roll-out of energy efficient lantern replacement programme to reduce energy consumption — Roads

Longford County Council Water Services section continues to operate at a high-level under the Irish Water Service Level Agreement Key Preformance Indications (KPIs). The KPIs cover all aspects of water and wastewater delivery from onsite treatment, treatment plant operations, budget management, compliance and back office supports. Figures for the first half of 2021 show KPI score averaging 96.95% – Water

A total of 134 employees participated in climate action training. Climate action is incorporated into the contracts of employment for new employees. Climate action has also been incorporated into the Performance Management and Development System as a value-based objective for all employees – Human Resources

Have championed the use of digital first business processes, commencing the implementation of a number of systems that will see environmentally-friendly paperless processes implemented. These processes will reduce paper consumption, travel and massively facilitate a low carbon usage business model – Information Technology

The new community library building in Edgeworthstown has achieved the Nearly-Zero Energy Building (NZEB) Standard, the first of our civic buildings in the county to achieve this standard. With grant funding of €100,000 from the Department of Rural and Community Development. The Counucil have improved energy efficiency through the branch library network though upgrading lighting and heating, replacing windows and carrying out essential repairs − Library

The Longford County Development Plan sets policies which will protect our natural and built resources. The Planning Department assists individuals and communities to protect our built heritage – Planning
