

Longford County Council Ranked Fourth Nationally in Local Authorities Satisfaction Survey 2020

Longford scored very highly in the satisfaction rating with a 67 % score, fourth highest score of the 31 local authorities surveyed and just 2 % below the highest satisfaction score of 69%.



A New Interactive Outdoor Experience, The National Famine Way, Was Launched

The cycling and walking tourism market will provide a significant opportunity for County Longford as Outdoor Adventure and Activity Tourism such as walking and cycling have been identified as particular growth sectors nationwide.



Operation Phoenix Announced

At the September meeting of the Joint Policing Committee An Garda Siochana & Longford County Council announced plans to work in partnership in Longford Town Centre to improve the quality of life of those operating a businesses, those living & those shopping in the County Town. We will engage with the relevant organisations & businesses to understand what needs to be done to improve the attractiveness of the town centre & to address the anti social behaviour experienced in recent times. From this month onwards members of the Gardai will patrol Ballymahon Street, Main Street & Dublin Street daily as part of what is being termed Operation Phoenix.

Community Development

Longford Local Community Development Committee (LCDC)

The next meeting of the Local Community Development Committee is scheduled to take place on Tuesday the 13th October 2020.

Community Enhancement Programme 2020 – Fund for Community Centres and Community Buildings

The Department of Rural and Community Development (DRCD) launched a new fund on the 10th August under the CEP, which will provide capital grants towards the maintenance, improvement and upkeep of community centres and community buildings and for adaptations or equipment needed as a result of COVID-19.

€5m has been provided nationally with €109,088 allocated to Longford LCDC. This funding is targeted at measures that stimulate local economies, while enhancing community facilities for individuals and communities that are impacted by disadvantage as identified in the Local Economic and Community Plan (LECP). Applications for the fund were advertised on the 11th August and a total of 65 applications were received by the closing date of the 16th September 2020. The CEP Evaluation Committee is scheduled to meet on the 29th September to evaluate the applications, their recommendations will be sent to the LCDC members for consideration at the LCDC meeting on the 13th October 2020.

SICAP

Longford Community Resources Clg, the Programme Implementer for the SICAP Programme, is continuing where feasible to roll out the programme. Staff are engaging with individuals and groups virtually. The LCDC approved the Midyear review of SICAP subject to minor adjustments to the recording of Key Performance Indicators. Pobal has provided clarification and guidance on the matter and a further meeting is scheduled to finalise the matter.

Comhairle na nOg

Virtual meetings will continue. Members conducted a survey on the impact of Covid-19 on young people's mental health, social health and education. Members are beginning preparations for their AGM scheduled for November. The AGM will be held virtually which will require a significant amount of work with all the post primary schools and youth services throughout the county.

Resettlement Programme

Respond will continue to provide support to the Syrian community in Ballymahon and Granard following the approval of an extension to November 2020. **Dormant Accounts Funding for LGBTI Groups** Funding of €10,000 was secured from the Department of Rural and Community Development for work with two LGBTI groups in Co. Longford.

Longford Intercultural Strategic Plan

Longford Intercultural Working Group is continuing to meet and share information. Members are presently updating actions in the Strategy. Support is ongoing with migrant groups to enable them to access various funding streams. **National Integration Fund 2020**

An application was submitted for an Integration Officer under this funding stream. This need was identified in the 2018-2022 Intercultural Strategic Plan.

CLÁR Funding 2020

A total of ten applications under Measure 1 Support for Schools/Community Safety Measures and Measure 2 Community Recreation Areas were submitted to the Department of Rural & Community Development by Longford County Council on 28th August 2020. The Department expects to decide on applications by the end October / early November 2020.

We offered a free draw to anyone who cycles into work during this week or sends us in a picture of you and about enjoyed your cycling. There was a cycling event or more on each day of the week.

A European Commission led initiative; European Week of Sport aims to increase the level of participation in sport and physical activity in the EU. All events were free of charge and ranged from lunchtime fitness classes, morning sunrise yoga, morning fitness classes, the mall mile with goody bags, taster session in stand up paddling and kayaking, walks, Nordic walking workshop, taster sessions in Pickleball, Table Tennis, seated Pilates, Badminton and much more. For volunteers we had an autism in sport workshop, a nutrition workshop and again much more.





Longford County Library Heritage and Archive

Edgeworthstown Community Library

Work is progressing well on this project although it is approx. 6 weeks behind schedule. There is great interest & anticipation in the local community. We are working towards a finish date end of 2020 -early 2021.



Longford County Library

The library continues to connect with customers and has increased our opening hours across all of our branches which now operate 6 days Monday to Saturday. Footfall is slowly increasing among our older customers and families with a big demand on our IT, photocopying and printing services. There continues to be a big growth in usage of our online services including, e books, e audio books, online newspapers, language learning and much more. Compared with the same period last year usage of our BorrowBox service has doubled in line with the experience of other library authorities nationwide.

Longford Age Friendly Programme

Keeping people connected! The strong focus of this programme throughout Covid19 was on keeping our older citizens connected and minding their mental health and wellbeing. We have applied for funding to run basic digital skills training to assist them to keep in touch with family and friends and to do some of their business online. The training will be tailored to their individual needs. We are exploring the best method of delivering this safely through a combination of online and inviting small groups who are not using technology to the library.

Creative Ireland

Most of the planned annual programme is now going ahead online although many of the annual festivals had to be cancelled. This is a very difficult time for working artists as there are no opportunities to perform live or earn an income from their work. Our focus has been on giving them a platform to create work and present it online. A collaborative project with Backstage Theatre allowed us to offer 3 theatre residency bursaries of 5,000 euro each to three professional Longford writers to create new work or to develop projects to completion stage. Culture Night which took place on Friday 18th September was a great success with our Cathaoirleach opening the event at Ballymahon Library and 7 online cultural events receiving a very high online viewership. A successful application for funding for an intergenerational choir project getting children and older people singing together is now being developed in partnership with local schools and Longford Older Persons Council.

Longford Decade of Centenaries programme

Longford was one of the counties with the most intense activity in the War of Independence, especially in 1920-21. The month of November has been designated as History Month in County Longford and a full programme of events has been developed which will focus largely on Ballinalee and Granard this year. A schools education pack is being worked on for all schools in the county and the overall programme will have a strong focus on making our children and young people more aware of their rich history and heritage. A large element of the programme will be delivered online.

During the month of September Suicide Prevention Training was offered to all employees and we supported and promoted the 'Escape your Chair' campaign held by the Irish Heart Foundation.



Regeneration

Towns & Villages Scheme 2020

On 11 September 2020 Heather Humphreys, Minister for Rural and Community Development announced details of the projects approved for funding under the second round of the enhanced Town and Village Renewal Scheme 2020 that supports towns and villages to respond and adapt to COVID-19. Longford County Council Regeneration department are happy to announce that a total of €86,843 has been awarded to the county under round two of the Scheme. This follows on from €104,040 awarded on 3 August 2020 under round one of the Towns & Villages Scheme 2020. Funding is being provided under round three of the scheme for larger towns as an exceptional measure and we await an announcement on the applications submitted by the Regeneration team. Further applications are being submitted to the Department by 30 September 2020 under the Main Scheme.

Edgeworthstown Library and Public Realm Undergrounding of services is complete and street lighting is operational along Edgeworthstown Main Street. Consultant architects have been appointed for public realm works and detailed design is complete. Construction work is progressing well on the library with the structural timber currently being erected. The project is due to be completed by the end of 2020.

Just Transition Fund

Applications were put forward with regard to climate action, economic and community development, tourism, employment and natural amenity for projects to progress the Just Transition process in Lanesborough, County Longford. Funding for projects €100,000 and under were announced in September 2020, with Longford County Council Regeneration team securing funding for the preparation of a largescale feasibility study for Lanesboro Renewable Energy Transition - Anaerobic Digestion facility and potential associated enterprise development. It is expected that the feasibility study will outline the benefits and impacts of the facility on the horticultural, agricultural, industrial and transportation sectors in the region and outline a programme of stakeholder involvement to ensure the transition to a socially and environmentally

Mid Shannon Wilderness Park

Clandillon Civil Consulting Limited have been appointed to carry out detailed design and environmental assessments for the development of a greenway network throughout the Mid Shannon Wilderness Park, linking it with existing routes in the south of the County and national and regional networks, including a bridge crossing at Kilnacarrow. The Mid Shannon Wilderness Park in Longford will be developed in partnership between the various owners including Bord na Móna, local communities and Longford County Council



Housing

- The Summary of Social Housing Assessment has commenced, the purpose being to capture the total number of households qualified for social housing support across the county whose social housing need is not being met, in order to understand the level of need for such support. 300 qualified households will be reviewed whom are not currently in receipt of social housing support, to ensure that they still want and qualify for support, and to ensure that the detail of the applicants' household is up to date and accurate.
- The Homeless Action Team recommenced meeting this month; the focus of this interagency group is to discuss the needs of homeless people and put in place support services to enable them to secure accommodation and tenancy sustainment.
- Disabled Persons Grants (DPGs) / Improvement Works in Lieu (IWILS) 2020 Allocations were recently announced, Longford County Council allocation is €208,613.42, 90% of this is exchequer funded with 10% match funding required by the Council.

- Works are progressing well on a number of projects on site currently including: 6 OPDs at Rose Cottage, Ballinalee; 5 no. units, Church Street, Edgeworthstown; 1 no. unit, Fairgreen View, Longford; 1 no unit Cloonahard, Longford; 18 /22 units Legan; 16 no. units Farnagh Hill, Longford.
- A total of 67 units have recently been approved for funding of €1,886,813.00 under the Voids Programme 2020 and July Stimulus Funding, for standard voids and long term voids / vacant units. Works are progressing well with over half complete to date.

The Environment Team had another successful conviction in the District Court this month under the Litter Pollution Act. The offender was fined €750 plus €500 costs.

Roads

Roadworks continued throughout the County during September.

The N4 Mullingar to Longford (Roosky) Project is being progressed and is currently in Phase 2, Option Selection. Traffic counts associated with the Scheme commenced on September 21st. In Longford Town work on the N63 Market Square

to Flancare Pavement Scheme which commenced on August 24th is continuing. Priority Construction are currently constructing new kerblines, footpaths etc and will continue to progress works on this Scheme over the coming months.

Rehabilitation/replacement works at Ballinamuck Bridge, Foygh Bridge and Killinlastra Bridge are complete.

Safety Barrier Repair Works have been completed in most of the County except Newtownforbes where additional barrier works are due to take place in October.

Design Works are continuing on the N4 Newtownforbes Pavement Scheme, N55 Ballymahon Main Street Pavement Scheme and various other Schemes throughout the County.



Successful funding applications under Active Travel Measures Allocation and Climate Change Adaptions Allocations were submitted. Construction Works on these Projects to commence as soon as possible. Tender Assessments on a New Public Lighting Maintenance Tender and Traffic Signals Maintenance Tender are ongoing. 2021 Funding Applications are currently being prepared for Regional & Local Road Low Cost Safety Schemes and Bridge Specific Grants. Works funded under the Roads Programme, C.I.S., Active Travel Measures, Climate Change Adaption, L.I.S., Clar and Regeneration were progressed in each Municipal District. Routine Works such as Street Cleaning, Hedge

Ensuring compliance with Strategic Environmental Assessment and Appropriate Assessment etc. Councillors considerations now being included in pre-Draft Plan for October meeting.

Water Services

The business continuity of the Water Service section is considered to be of significant priority for both the county and the state at the present time while Longford County Council continues to plan and deliver the functions of the Water Services section throughout the county.

The Water Services Capital section continue to provide services during the current COVID-19 pandemic in terms of ensuring continuation of service of drinking water for the County particularly in areas with headroom/supply issues.

Find & Fix Programme

Longford County Council and Irish Water commenced the Find & Fix programme in County Longford in May 2019.

This is a national project aimed at delivering major water leakage savings.

Find & Fix crews are currently operating in the:

- Killashee Street (2nd Sweep)
- Ballymakeegan (2nd Sweep)
- Granard
- Edgeworthstown-Castlepollard DMA's.

It is anticipated that the Find & Fix works in County Longford will continue as the year progresses. Photo below shows a leak repair completed by the Find & Fix team in Granard recently:



Asset Needs Briefs (ANB's)

Water Services Capital Section continues to submit Asset Needs Briefs to Irish Water for defective watermains identified during the Find & Fix programme in order to secure funding for watermain upgrade works.

ECI Water Programme

Irish Water in consultation with Longford County Council has recently commenced the ECI (Early Contractor Involvement) Programme in County Longford. This is a national programme aimed at carrying out appropriate improvement works at water treatment plants throughout the country to ensure the continued delivery of safe drinking water. To date Irish Water have assessed over 811 sites and completed upgrade works to over 230 sites. The programme is currently at detail design and planning stage for the Lough Forbes WTP while works have recently commenced at Lough Kinale (Granard) WTP and Lough Gowna (Smear) WTP:



Rural Water Programme

We are facilitating the group schemes that were successful in potential funding. Bids for the Multi-Annual Rural Water Programme 2019-2021 were submitted in March 2019 and we are now looking for possible bids for the next rolling period. Clonmore/Kilmore have received tenders for consultancy work for upgrade works on their group water scheme. Total Funding under the Multi-Annual Rural Water Programme in the sum of €225,400 was notified to Longford Co. Co. in October 2019. It is anticipated that some of this funding will be drawn down in 2020.

Veterinary Services

Veterinary and Dog and Horse Control services are identified as essential services to support safe local food production and animal welfare and animal control during the Coronavirus Covid-19 Pandemic.

The Local Authority Veterinary Service has produced a Pandemic Action Plan, a Business Continuity Plan and a Resource Recovery Template.

In addition, the Local Authority Veterinary Service, in conjunction with the LGMA, provided a COVID-19 Animal Related Queries document to support the LA Community Call service

LGMA/CCMA continue to negotiate with the FSAI to ensure adequate funding of Official Veterinary Controls, particularly in support of Longford's local meat producers, and to secure all the other functions of the local Authority Veterinary Section for the long term. The Dog Control Service assisted An Garda Siochana at checkpoints in county Longford recently to assist in counteracting illegal dog movements and dog thefts. The Dog Warden continues to care for stray and unwanted dogs all though the year.

Stray dogs are hazardous to people, farm animals and other pets and our service keeps all of our community safe while also being very committed to the welfare of these dogs
