May–June Highlights

Local Elections 2024

The Local Elections 2024 took place in June. In Longford County Council, 18 elected members were elected, including six first-time county councillors.



National Famine Commemoration

The National Famine Commemoration took place in Edgeworthstown, a first for County Longford and a first public engagement for the new Taoiseach Simon Harris TD.



Microsoft Dream Space Showcase 2024

The second year of the Longford Microsoft Dream Space Showcase took place with 450 students presenting over 100 STEAM projects.



Active Travel official openings

Minister of State Jack Chambers opened Safe Routes to School and Active Travel schemes in County Longford in Newtownforbes, Enybegs and Longford Town.



Community Development

CLÁR 2024

The Minister for Rural and Community Development, Heather Humphreys TD, launched the CLÁR 2024 Scheme.

CLÁR Measure 1 is administered by local authorities and provides grants from €5,000 to €50,000 to support the development of community and sports facilities and more. It closed for applications in May and a priority list of fifteen projects was sent to the Department of Rural and Community Development (DRCDD) for consideration. A funding announcement is expected in October.

CLÁR Measure 2 and Measure 3 are administered by the DRCDD. Both closed for applications in June.

Healthy Longford

Healthy Ireland Fund

Sixteen projects in Longford have been approved for the Healthy Ireland Fund. These projects meet an outcome set by Healthy Longford through Healthy Ireland Fund 2023-2025. These outcomes are:

- Increase in % of adults and children meeting physical activity guidelines
- Increase in positive mental health as per Energy and Vitality Index

Hello, How Are You?

Hello, How Are You? is an initiative facilitated through Mental Health Ireland. It took place in May with two coffee mornings in Ardnacassa Community House and McEoin

Community House. This initiative provides opportunities for meaningful connection and conversation encouraging that a simple Hello How Are You can make a world of difference.

CYPSC Trauma Informed Care Conference

CYPSC Trauma Informed Care Conference took place in May in Mullingar. Healthy Longford was a partner and co-funder of the Conference which explored the value of a trauma-informed approach in services for children, young people, and families. This excellent learning opportunity was organised through Longford Westmeath CYPSC.

Longford Breastfeeding Project 2024

Healthy Longford is linking with an established working group focused on a Longford Breastfeeding Project 2024 under Healthy Ireland Fund 2024. The first two initial meetings have provided scope and a plan for the aim of this project in 2024.

Social Inclusion Community Activation Programme (SICAP)

In May, the Department of Rural and Community Development allocated Longford Community Resources CLG (LCRL) an additional €15,000 to the 'New Arrivals' allocation of €79,026 for 2024. LCRL have indicated that this funding will be used to employ a New Arrivals Support Worker and towards programme money for one-to-one supports.

Community Development

Longford Comhairle na nÓg

Longford Comhairle na nÓg members attended the Dáil na nÓg in the houses of the Oireachtas. Members got to take their seats in the Dáil chamber and were addressed by the Ceann Comhairle Sean O’Feargail and Minister Mary Butler TD, with a surprise meeting with the Taoiseach in waiting at the time Simon Harris TD. Members deliberated and voted on aspects of mental health that directly affect young people. The key topic that went forward to be addressed was school stress. This was a wonderful experience and opportunity for our Comhairle members who thoroughly enjoyed the day.



Africa Day 2024

Africa Day celebrations are organised by Irish Aid at the Department of Foreign Affairs in partnership with African embassies in Ireland and local authorities around the country. Longford County Council secured a maximum of €7,500 on behalf of Longford African Network who hosted an event in May in Longford Athletic Centre. This year’s event showcased the unique offerings of African countries through dance performances, music entertainment, craft displays and staple foods.



LEADER 2023-2027

LEADER 2023-2027 was launched with a budget of €5.8M to support businesses and communities in County Longford. Longford Local Community Development Committee (LCDC), Longford County Council and Longford Community Resources Clg announced the start of this programme which will support the development of rural communities and enterprises.

Community Development

Between now and the end of 2027, Longford Community Resources as the LEADER implementing partner working closely with Longford LCDC and Longford County Council, will invest €4,350,000 in LEADER funding in innovative community and enterprise projects focusing on the following themes:

- Theme 1: Economic Development and Job Creation
- Theme 2: Rural Infrastructure and Social Inclusion
- Theme 3: Sustainable Development of the Rural Environment and Climate Change Mitigation and Adaptation

LEADER Funding Information sessions were held in June to help community groups, organisations or businesses interested in applying for LEADER funding.

Longford Local Community Safety Partnership

All Ireland Community Safety Network: Domestic Sexual and Gender Based Violence Good Practice Sharing Session

Longford Local Community Safety Partnerships (LCSP) secured funding to arrange six gatherings of Community Safety Partnerships in the Republic of Ireland and Northern Ireland over the next two years. This funded was secured in conjunction with the Dublin and Waterford LCSPs, Drogheda Implementation Board and Newry Mourne and Down PCSP. These meetings will build on the

work and networks developed at the Beyond Borders Community Safety Conference held in 2022.

The first event of the All-Ireland Community Safety Network was held earlier this year in Drogheda. Several LCSP members were in attendance. Longford Women's Link was one of the agencies leading a 'Sharing Good Practice' Session and spoke of their work around the '8 Stages to DV Homicide' and the Interagency Model Working Group.

Other speakers included the Department of Justice Northern Ireland and the Department of Justice Dublin, the PSNI, and An Garda Síochána. The other shared learning sessions came from Women's Aid Newry (DASS project) Mens Aid in Drogheda (Intimate Partner Violence in the LGBTQI+ Community) and Seeking Safety (Drogheda Red Door Project).



Community Development

Community Safety Ambassadors

Longford LCSP, working with An Garda Síochána and the Age Friendly Programme, have revised the Crime Prevention Ambassador Programme and renamed it the Community Safety Ambassador Programme to reflect the wide remit of the Community Safety Partnership. This is a peer-to-peer information-sharing initiative, where trained ambassadors share community safety and crime prevention advice with their own network.

A pilot training session took place with 12 volunteers in Longford Garda Station to test the new training module. Attendees were sought from the Older Peoples Council, several minority communities in Longford, and TidyTowns Longford. Led by the Community Safety Coordinator, presentations were given, including from Age Friendly Programme Manager Martina Needham and Longford Crime Prevention Officer Sargent Damien Bartley.

Feedback was good and some suggestions were made to help improve the training module before it is rolled out across the County. Ambassadors were given a handbook, branded hi-vis jacket, information packs. Meetings will take place every two months to give new briefings and to hear the issues and concerns from their communities. Longford now has 12 trained Community Safety Ambassadors, and we hope to hold more training sessions for larger groups in 2024.

Kids Court

Along with An Garda Síochána, the Longford Local Community Safety Partnership held two Kids Court events so far in 2024:

- Sacred Heart National School in Granard
- Scoil Samhthann in Ballinalee

Over 50 children took part in Kids Court with 10 drivers coming before the jury. Students also learned about roads policing, tried out the speed gun and spoke candidly about their views on speeding and road safety in their area to the Gardaí and community safety team. Feedback has been excellent from the children and schools taking part.

Drivers who took part were typically going marginally over the speed limit while several drivers identified going significantly over the limit were given a fine and penalty points. Drivers who did go through the process all felt that it was a difficult process to be asked the questions by children who may have been seriously injured or killed if an accident took place. All agreed it has impacted their attitude and awareness to speed limits around schools.

Bike Week 2024

Promoting the benefits of cycling, Bike Week took place in May. Many events were held in the county with the Royal Canal Greenway providing the idea starting point for many activities. Over 600 people came along to community leisure cycles, school and social cycles, and children learn to cycle events. Events were organised by Longford Sport Partnership took place. Bike Week is funded by the Department of Transport through the Transport of Ireland (TFI).



Prime Time of Life

Prime Time of Life is a 12-week twice-weekly exercise training and health education programme for older adults and adults with chronic conditions. Taking place from May to July, 42 people signed up for the programme which is delivered in Longford Sports Hub.

The training includes aerobic, resistance, balance, and flexibility exercises. It aims to improve strength, balance, flexibility, and cardiovascular health. It also aims to improve mental health and quality of life of participants. Before beginning the programme, baseline health indicators were measured. These will be compared to indicators taken at the end of the programme to identify expected improvements.

Summer Sports Inclusion Initiative

Every Saturday in May the Summer Sports Inclusion Initiative took place at Mc Eoin Park Recreational Park. It focused on GAA and Rugby with around 40 children participating. Many participants come from disadvantaged backgrounds, including children from the Traveller community.

It aims to foster teamwork in a supportive and inclusive environment. It aims to create a sense of community among participants and encourage a love of physical activity which contributes to the children's overall wellbeing and development.

Due to the success of the initiative, it is hoped to extend it through the summer.

Inclusion Sports Days

Longford Sports Partnership and Longford GAA worked together to arrange Inclusion Sports Days for the following schools: St Marys National School, St Matthews National School, St Teresa's National School, St Colmcille National School, Sacred Heart Primary School, and St Joseph's National School. Over four days, 132 children took part.

Four Longford GAA coaches assisted and helped make these days possible. The sports days were held either at the participating schools or in the Longford Sports Hub. There were structured games, as well as free unstructured play. Feedback from teachers, special needs assistants and parents has been overwhelmingly positive.

Libraries, Archives, Arts and Heritage

National Famine Commemoration Day

The National Famine Commemoration took place in Edgeworthstown on Sunday, 19 May. Taoiseach Simon Harris TD officiated at this formal State ceremony and gave a keynote address. The Taoiseach also took part in a wreath-laying ceremony in remembrance of all those who died during the Famine and military honours.

His Excellency The Most Reverend Luis Mariano Montemayor and Dean of the Diplomatic Corps, Apostolic Nuncio and Longford County Council Cathaoirleach Cllr Colm Murray planted a Longford oak tree and laid a wreath with the Taoiseach.

Minister for Tourism, Culture, Arts, Gaeltacht, Sport and Media, Catherine Martin TD and ambassadors from over 70 counties were also in attendance on the day.

Music was provided by Streancán and musicians Dr Conor Ward, Noel Carberry and Meadhbh Carberry.



Amy Rooney Maguire, Emma Mihai and Aaron Ó Míacháin from St Mary's National School, Edgeworthstown performed the poem An Píobaire Uillinn. Matt Farrell read extracts from the letters of Maria Edgeworth.

Freya Lilly O'Connor, Jack Garrett Cuffe and Thomas Denniston from St John's National School assisted the Taoiseach, our Cathaoirleach and the Dean of the Diplomatic Corps with the planting of the tree oak trees. These oak trees will be re-planted in September – one in each municipal district.

The ceremony was broadcast on the RTÉ News channel and is available to watch on the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media's YouTube channel.

Longford Microsoft Dream Space Showcase

The second year of Longford Microsoft Dream Space Showcase saw over 450 children from 18 primary schools demonstrate over 100 STEAM (science, technology, engineering, arts, and maths) projects.

Industry partners who exhibited on the day included Microsoft and Ericsson. Fourteen different Council sections also exhibited including the Libraries and the Arts Office, Environment, Longford Sport Partnership, the Fire Service, Civil Defence, Community, Roads, Information Technology, Local Enterprise Office Longford, Comhairle na nÓg.

Summer Stars

Summer Stars is a free national summer reading programme for children running until the end of August. Children are encouraged to enjoy the fun and pleasure of reading and writing. It is non-competitive and every child who reads even one book or e-book is regarded as having completed the programme. All participants are included in a draw for book hampers worth over €100. A draw will take place in each library this September.

My Little Library Book Bags

My Little Library Book Bag is filled with books which aim to help children preparing to take the big step of starting school this year. It can be collected by children and parents and guardians for free from any County Longford library from June.

This is an initiative between libraries, the Department of Rural and Community Development, and the Department of Children, Equality, Disability, Integration and Youth as part of the First 5 Strategy.

Each My Little Library Book Bag contains a book on starting school, making friends or being comfortable to be yourself, and a library card and special My Little Library cardholder. Book bags are available in both Irish and English.

Longford Age Friendly

During May, our libraries hosted activities to celebrate Bealtaine, with a 'Lust for Life' theme for this year's festival. It got off to a lively start with a concert in Ballymahon Library where there was lots of singing, music, and dance. It featured Angela Reynolds and her songbirds' choir with guests. Other Bealtaine events focussed on arts and crafts, dancing, health, wellbeing, and sustainability. Over three hundred attended these events in the libraries.



Move Well for Health Classes are continuing in five libraries. This is organised by Longford County Council Physical Activity for Health Officer with Longford Sports Partnership and Longford Libraries. The classes which include falls prevention, step and strength classes and a pole activator class have proved to be very popular with all participants. There is a break over the summer months with the next round of classes starting in September.

Libraries, Archives, Arts and Heritage

Older Person's Council Chairperson Kitty Burkhill and Paula Mulry represented Longford Age Friendly Programme at the annual Older Person's Convention in Kilkenny. The theme of the Convention was 'Ageing with Independence'. With opportunities to network, discuss topics and share ideas, the Older Person Councils has members from different counties.



Kitty attended the Ambassador Launch Day in Slane Castle accompanied by our Age Friendly Ambassador, Declan Nerney. Declan will be promoting the Ageism Awareness Campaign and the Age Friendly movement this year.

Kitty also attended the inaugural meeting of the Commission on Care for Older People Reference Group chaired by ERSI Chief Executive Officer Prof Alan Barrett. This event looked at the provision of health and social care services and supports for older people. It makes recommendations to the Government for their strategic development.

Longford Age Friendly and Regeneration staff attended a walkability audit in Castlepollard by invitation of Westmeath County Council Regeneration and Age Friendly Teams. It is hoped that this template will be replicated when designing Longford walkability audits in Ballymahon and Granard this autumn. Following the National Launch of the Age Friendly Libraries Charter in Edgeworthstown Library, the Older Persons' Council have agreed to carry out walkability audits in each County Longford library in August.

Longford Age Friendly Programme will be making an application across several categories for the Annual Age Friendly Recognition and Achievement Awards which will be held later this year. These awards highlight efforts to enhance the quality of life for older adults that not only make a difference but also set a benchmark for others to follow.

Musical Memories project

The Musical Memories project aims to capture and share the personal stories of Longford musicians and the impact of music on their lives. It is a creative collaboration between CO:WORX Edgeworthstown, Creative Ireland, Longford Libraries and Age Friendly. This initiative bridges generational gaps and brings creativity into our remote working hub. It is funded by Creative Ireland, Longford and led by CO:WORX.

The aim was to create a digital archive of Longford musicians from across the county. The project features Sean Marshall (flute), Jimmy Whelan (accordion), Mary Brady (fiddle), Noel

Sweeney (fiddle and saxophone), Olive Kilbane (fiddle and singing), Bernardine Farrelly (harp), Michael Owens (guitar), and Brendan Daly (keyboards).

Earlier this year, the eight musicians shared their music and stories. Jimmy Connell from the Jimmy Jests interviewed each musician, while Lee Williamson from Shuttermanic Productions filmed the event and music sessions. Clare Frances Photography captured portraits of the musicians with their instruments. It concluded with an impromptu ceilí.

On the 18 June, friends and families of the musicians gathered at Edgeworthstown Library to watch the short film 'Musical Memories – Echoes from Longford April 2024'. Longford County Council Chief Executive Paddy Mahon presented each participant was presented with their portrait and a copy of the video. The evening was filled with lively music and community spirit.

Archives and Records Management

The Archives service is working on the metadata for the development of a major digitisation project with the Virtual Record Treasury of Ireland, involving the archives of the boards of guardians of the poor law unions. The Archivist and Assistant Archivist worked with the Library, Motor Tax, Traffic, Environment and Corporate Services Departments to authorise the destruction of records according to the National Retention Policy.

Two aerial photographs of part of Longford town, taken in 1974, were donated.

The Archivist participated in an online skill share session, organised by Libraries Development in the LGMA. The Archivist spoke about outreach projects and how we engage with local groups. An audience of 75 library staff from around the country attended online.

Arts Office

County Longford Arts Bursary Awards: Assessments were finalised, and grant offers were made to the 11 artists to support their practice and professional development in the following areas: Music, Visual Arts, Circus, Photography and Theatre.

County Longford Arts Project Awards: Assessments were finalised, and grant offers were made to the following 10 arts and culture organisations in Longford to deliver projects, events, and festivals in 2024.

The Longford Arts Office supported the recent Young People, Children and Education Project Award (YPCE) application for the project Making Moving Art. This application was successful in receiving funding in 2024.

Making Moving Art is designed to support young Roma and Traveller children to make a successful transfer to secondary school by involving them in an innovative performance programme to learn new skills and be able to represent themselves and their culture. The programme involves learning drumming, drama, dance, and circus. The programme is a partnership between Longford Arts Office, Longford School Completion Program (LSCP), St

Michael's Boys National School and St Joseph's National School. LSCP is the lead partner.

Longford Arts Office supported Bula Bula Samba Band to organise Longford's first Pride Parade and Festival on 15 June. This project received funding and supported from the new night-time economy (NTE) element of the Cruinniú na nÓg programme. This event was an enormous success with over two hundred people in attendance.

Creative Ireland

Twenty-six community projects received Creative Ireland funding, including Granard Booktown, Maria Edgeworth Festival in Edgeworthstown and the Goldsmith Festival in Ballymahon. Three community choirs, several theatre productions, poetry workshops, art classes were also supported.

The summer will be packed with load of activities as well including Granard Midsummer festival, climate action upcycling, recycling and sustainability workshops in Ballymahon and Camlin Keys Piano Festival in Longford.

Cruinniú na nÓg

Ireland is the first and only country to have a national day of free creativity for children and young people. This year it was held on 15 June. With 21 events in eight locations, over 500 children tried music, art, crafts, circus skills, dance and more.

Cruinniú na nÓg is a flagship initiative of the Creative Ireland Programme's Creative Youth Plan to enable the creative potential of children and young people.

Creative Health and Wellbeing in the Community Scheme 2024

Longford and Westmeath County Council submitted a joint application for the Creative Health and Wellbeing in the Community Scheme 2024. The project 'Interwoven Threads: Ireland's Migrant Stories' was awarded €140,000.

This project will explore the similarities between the Irish emigrant stories and those of immigrant stories of the new Irish. It will highlight similarities of these stories, show the benefits of integration and social inclusion, including creating social cohesion and reduce social isolation. The stories will show the customs and cultures of both communities and their common threads.

This project will work with key new and established communities to explore the impact of anti-immigrant behaviour, including on mental well-being, perceptions of safety and inclusion in local community groups.

Healthy Ireland

Longford Libraries hosted a stand at a men's health morning at Longford Athletics Centre, showcasing Healthy Ireland at Your Library and the services offered by Longford Libraries.

Edgeworthstown Library hosted a 'Hello, How Are You' coffee morning in partnership with Mental Health Longford. Finola Colgan from the HSE attended and there was an open conversation around mental health.

Events have been organised for July, including information sessions by a kinesiologist and an optician and workshops with a sensory play therapist. Bookings are already coming in on the library's website.

Libraries, Archives, Arts and Heritage

Heritage

The Community Monuments Fund 2024 provides for the care, conservation, maintenance, protection, and promotion of archaeological monuments. It also considers the impacts of climate change on such monuments.

The fund is prioritised for local authorities, private owners and custodians and community groups. Total funding available nationally will be €7,000,000.

Four Longford projects were awarded €133,102.50 in funding from Stream 1 and 2 of this Fund. They include projects in Clondra, Abbeylara Cistercian Abbey, Abbeyshrule Abbey and Saints Island.

Planning is underway for Heritage Week, which takes place from 17-25 August.

Corporate Services

Customer Services

Customer Services responded to over 1,700 calls in May and June, as well as responding to emails and many in-person customers.

Register of Electors

Over 2,000 applications were processed in the lead up to the Local and European Elections. These include many first-time applications registering to vote and those wishing to update their details. There was also a large volume of applications from electors to be included on the postal voters list.

Local and European Elections 2024

Support was provided to the Local Returning Officer and the European Returning Officer in the lead-up to the Local and European elections. The Corporate team were available by telephone to assist electors and presiding officers on polling day.

Official Languages Act

Work continues to meet our obligations under Section 10A of the Official Languages Act (Amendment) 2021. In May and June, a total of 314 advertisements were placed, with 90 in Irish or bilingual.

Housing Section Senior Executive Engineer Orla Maguire gave an update on the requirements of the framework and A/ Health and Safety Officer Amanda Cullen gave health and safety briefing on the role of PSCS and overview of the Longford County Council safety management system.

Workers' Memorial Day Ireland 2024

Workers' Memorial Day Ireland 2024 was marked earlier this year with a national and annual commemorative event to remember people who died, were injured, made ill and bereaved through work-related incidents. In Ireland in the ten-year period between 2014 and 2023, 459 people died in work-related incidents and many thousands more were severely injured or made ill. In 2023 alone, 43 people died in work-related incidents.

By working together and promoting the practice of safety and health in workplaces throughout Ireland we will achieve a significant drop in these dreadful deaths and injuries.

Just Transition: Investment Grant-Aid Scheme for Private and Community SMEs

Support is being provided to help those wishing to apply for the Just Transition Investment Grant-Aid Scheme for Private and Community SMEs. Expression of interests (EOI) were the first step in the application process, with a deadline of Sunday, 30 June.

Eligible EOIs can submit their full application by Monday, 13 January 2025. For this, any planning permission and/or statutory consents must be in place before this date.

Funding may be used for new and sustainable (or the expansion of existing) visitor attractions or tourist accommodation. Capital project planning and design and accessibility enhancements to visitor accommodation and attractions may also be funded.

National Famine Way Commemorative Walk

Longford County Council Cathaoirleach Cllr Colm Murray, Chief Executive Paddy Mahon and Longford Tourism made their way along the Royal Canal Greenway in Longford for the National Famine Way Commemorative Walk.

There they met with the Irish Ambassador to Canada Eamon McKee, the Canadian Ambassador to Ireland Nancy Smith, and Liverpool Irish Famine Trail representatives.

Scoil Mhuire, Clondra school children joined in to walk to the bronze shoes for a schools' ceremony. This was supported by Enchanted Croí Theatre.

A Longford welcome and hospitality was provided by Foigha Bar and Lounge in Keenagh, the Ticket Office in Ballybrannigan and The Farmhouse in Abbeyshrule. Knights and Conquests Heritage Centre in Granard surprised walkers with a display of famine time replicas. These replicas included a famine ship and a handmade cart by Martin Briody. Restoration specialist Eamonn Creamer created a replica sliding coffin as a commemoration to the missing 1490. Eamonn gave a demonstration of the sliding coffin, used in workhouses during the Famine.

Historian Grey Quiery from Liverpool Irish Famine Trail ended the day with a reading of the poem Vanished. You can view this on Longford Tourism's Instagram page.

The walk took place over six days from Monday, 20 to Saturday, 25 May. It passed through six counties, finishing at the launch of the Global Irish Famine Way at EPIC Museum in Dublin.

The National Famine Way is open all year. The route and associated stories can be found on its free National Famine Way app. Official National Famine Way passports can be purchased for walkers to get stamped in key locations along the route.

The National Famine Way is a collaboration between Waterways Ireland, the Irish Heritage Trust, and the local authorities along the route: Longford, Roscommon, Westmeath, Meath, Kildare, Fingal, and Dublin City.

An extension of the National Famine Way, the new Global Irish Famine Way will launch in 2024 and will become the largest heritage trail in the world. It will follow the journeys of all the Irish Famine emigrants around the world, including the UK, Canada, the United States, South Africa, and Australia. The Bronze Shoes that mark the National Famine Way will also mark each significant location on the Global Irish Famine Way. A series of commemorative events will mark their arrival. This initiative begins in 2024 in Canada and in Liverpool in the UK.

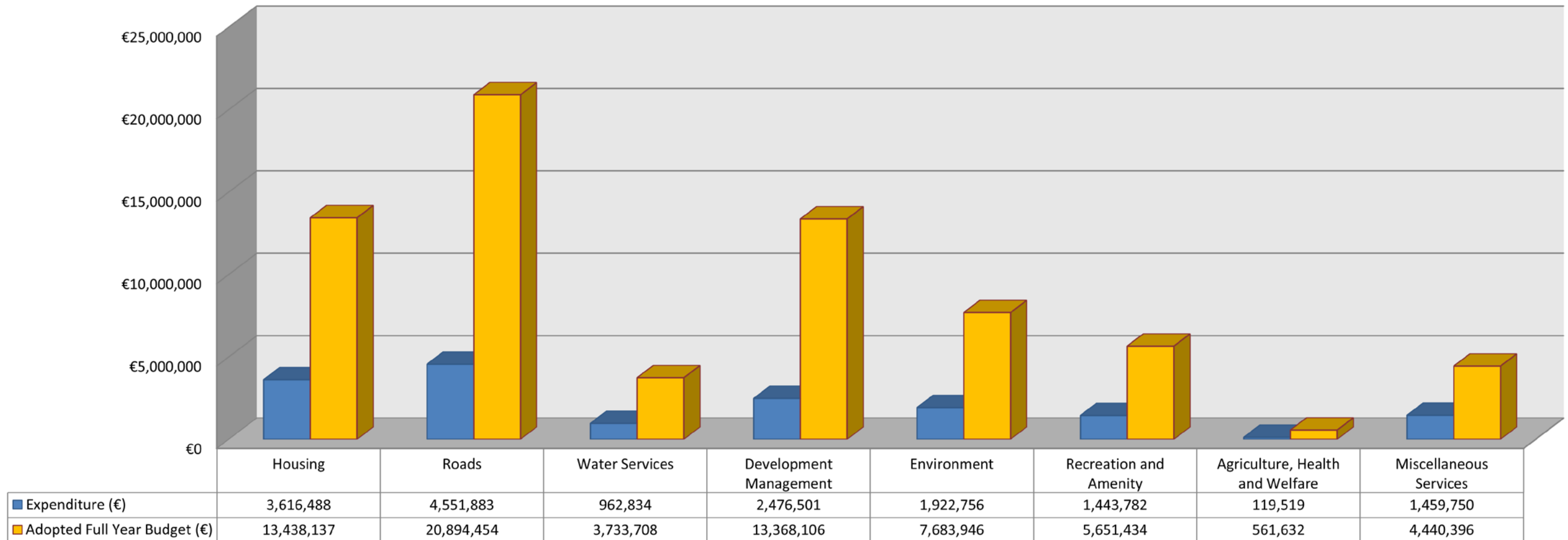

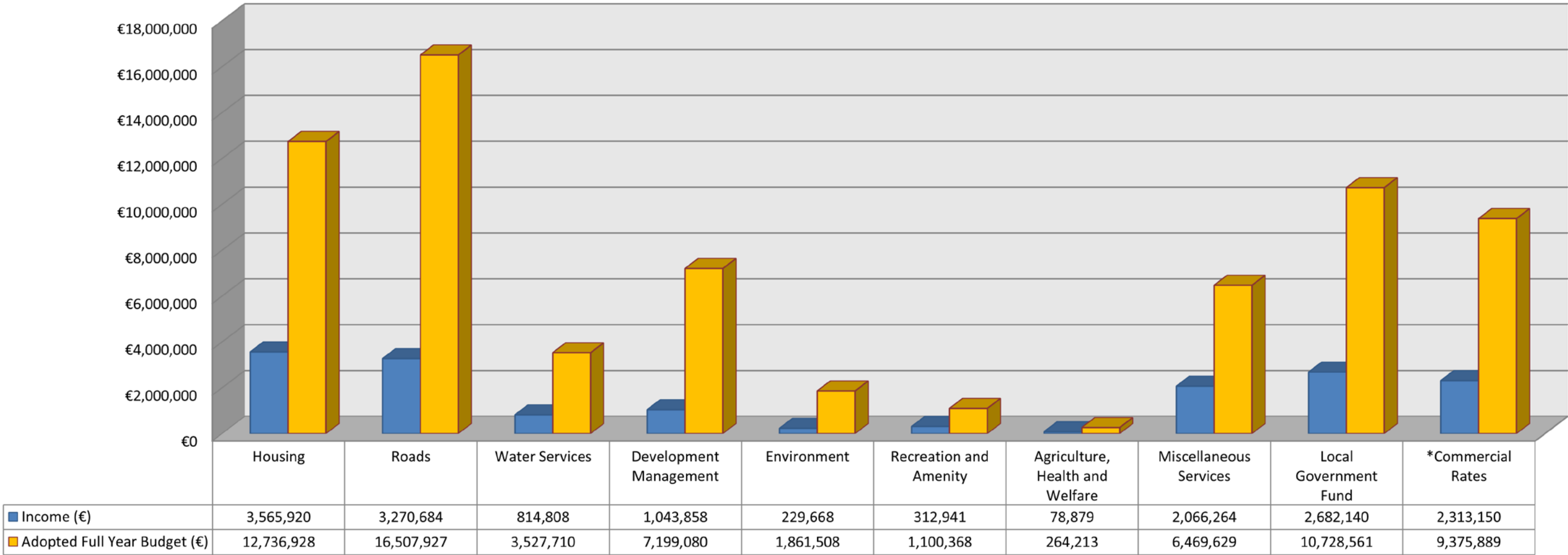

Information Technology

Longford Microsoft Dream Space Showcase

Over 450 children from 18 primary schools across the county took part in Longford Microsoft Dream Space Showcase 2024. The event took place on Friday, 24 May in Edgeworthstown with school children demonstrating over 100 STEAM (science, technology, engineering, arts, and maths) projects.

Longford's Microsoft Dream Space Showcase is co-funded by the Government of Ireland and the European Union through the EU Just Transition Fund Programme 2021-2027. The equipment was supported by Longford County Council and the Department of Public Expenditure, National Development Plan (NDP) Delivery and Reform under the Public Service Innovation Fund 2023.

The event was supported by Microsoft, Ericsson, Computex, and FIT (Fasttrack into Information Technology) who exhibited on the day. Other exhibitors included teams from across Longford County Council and local organisations including Comhairle na nÓg and Music Generation Longford. Connectivity was supported by Eir and Arden Broadband.

Longford Microsoft Dream Space Showcase is the culmination of months of engagement with schools including hands-on STEM sessions from the Microsoft Dream Space teaching team and a 10-week Dream Space TV programme. This included teaching school children computer science, micro: bit technology and artificial intelligence.

IT Infrastructure

IT infrastructural work includes 1,425 tickets on the Service Desk for this period. There was an IT set up and fit out for the new Longford County Council Church Street offices.

Other infrastructural work includes:

Longford Works is a network of remote working hubs across County Longford, in Abbeyshrule, Ardagh, Edgeworthstown, Longford Town, Moydow, Moyne, and Mullinalaghta. This project will be official launched in the coming weeks.

The STEM Passport for Inclusion initiative is continuing. This is led by Maynooth University, Microsoft Ireland, Science Foundation Ireland (SFI), and the Department of Education. Longford have successfully

completed this programme in three secondary schools: St Mel's College, Lanesborough Community College, and Moyne Community School. For the first time in this project, boys were able to participate.

Longford has secured €841,290 from the EU Just Transition Fund: Local and Regional Economic Strategies Support Scheme. This funding will be utilised by working in partnership with industry and schools to achieve the objective of having Computer Science a Leaving Certificate option in all nine secondary schools in Longford.

CRM rollout is ongoing for managing email queries. This includes its use for meetings administration, media enquiries, Roads and Human Resources, as well as for Ballymahon, Drumlish, Edgeworthstown, Granard and Longford Libraries.

Other digital services work includes:

- Tender completed for new cloud-based phone system
- ePMDS and Blended Working software being used by all employees
- Planning enforcements moved to SharePoint to automate mapping and automate business flows
- Testing of moving planning registers to SharePoint to automate mapping and automate business flows

Planning

Lough Ree Biosphere Reserve

The UNESCO application for Biosphere Reserve status for Lough Ree is progressing. Consultants have been appointed to carry out public consultation which is due to start in January following a Ministerial launch.

This project features in the National Climate Action Plan, Shannon Tourism Masterplan, Longford County Development Plan 2021-2027 and the Programme for Government and is a flagship project in the region in our efforts to combat climate change and reverse biodiversity loss.

Extensive discussions have been carried out between the consultants, the steering committee, and the secretariat regarding the boundary requirements. Public consultation is due to start shortly.

Planning Applications, Development Management

ePlanning has been fully implemented with over 80% applications now received online.

Development is due to start on the permitted extension to Center Parcs, which when completed will be a 50% increase in the accommodation levels at the holiday village.

There have been numerous Part 8 applications processed from Housing, Regeneration, and Active Travel.

The Waiver scheme in relation to development contribution has been extended with a modest uptake in applications. Planning are looking to make as many as possible aware of this scheme.

Residential Zoned Land Tax

A Draft map for the Residential Zoned Land Tax (RZLT) has been published, as required for Revenue Commissioners under legislation. Land appearing on the annual draft maps (amended to account for the outcome of submissions and rezoning requests) will be included on the annual final map of land within scope for RZLT in the local authority area. This is to be published on 31 January 2025. This land will be subject to the tax in 2025 unless it is exempt as a residential property or qualifying for any other exemption as specified within legislation.

Derelict Site

The Derelict Sites Act and process is being used as a vehicle to minimise dereliction and vacancy in the towns of Longford. The derelict site registration process has begun on seven sites.

Housing

Energy Efficiency Retrofit Scheme

The Energy Efficiency Retrofit Scheme is ongoing with this year's focus on targeting houses with the lowest BER rating. In 2024, the Department of Housing, Local Government and Heritage set a target of 45 units. To date, tenders received for six units at St Anne's in Ballymahon. Tenders are being prepared for six units at Abbeycartron Lane and 22 units at Casey Court, Kenagh. Energy efficiency works are also planned for Longford County Council housing stock, with 12 units submitted for Department for approval to date.

Repair and Leasing

In April, funding was approved for seven apartments at 42 Main Street, Longford. This is an AHB led scheme with Kilkenny Voluntary Housing Association. It comprises of four one-bed apartments and three two-bed apartments.

Compulsory Purchase Orders

Last year, six properties were designated for compulsory purchase orders (CPO) to convert them into social housing.

Section 8(7) Notices of Entry on the Derelict Sites Register and Section 11 Lists of Measures have been served to the property owners of three properties. If no engagement is made by the owners, the properties will soon be entered into the Derelict Sites Register, and the CPO process will begin.

Additionally, efforts are underway to CPO 10 properties in a state of disrepair at the St Michael Road and Wards Terrace area. Residents from the area have been engaged and are providing their local knowledge to identify ownership of the properties.

Derelict Sites

The Derelict Sites Register is being updated. Three properties were added earlier this year for CPO by Longford County Council. Seven properties were removed from the register due residents' efforts which improved these properties so that they are no longer considered to be derelict. Additionally, the Derelict Sites Levy is working to motivate owners to address dereliction.

Completed in 2023, the Vacant Property Survey data is being updated as part of the Vacancy Activation Programme. These updates reflect efforts to bring vacant properties back into use and activate derelict sites through available vacancy schemes.

Ready to Build Scheme

Participation in the Ready to Build scheme is currently being explored. To date, however, no potential sites have been identified for sale and participation in this scheme. Once the data entry for the CPO activation program is completed and the Derelict Site Register updated, details on proposed sites for participation in the Ready to Build scheme will be provided.

Housing

Vacant Property Refurbishment Grant (Croí Cónaithe)

The Vacant Property Refurbishment Grant Scheme, also called Croí Cónaithe, continues to support property revitalization. It offers €50,000 for vacant properties and €70,000 for derelict properties.

To date, Longford County Council has received 127 applications. Of this, six applications were withdrawn and three were refused. Additionally, three grants have been successfully paid out. Furthermore, 83 applications have received preliminary approval, with an additional 32 applications pending further information from the applicants.

Applications and Assessments

To date in 2024, 224 new social housing support applications have been accepted. Currently, there are 648 approved housing applicants on the Council waiting list. A further 190 are within the assessment process and 34 applicants have been allocated a property and await appointment.

New Tenancies

To date in 2024, 66 new local authority, AHB and Rental Accommodation Scheme (RAS) tenancies have started.

Rent Review

The rent review is now complete for all 2,342 households. Of this, approximately 200 households sought a reassessment due to further information submitted after their initial assessment or a change in household circumstance. There were approximately 100 hardship applications made. To date, three households have had a small reduction in rent having proved their need for a reduction. The remainder did not or have not yet submitted further information to support their application.

Tenancies were updated, included adding and removing occupants, and changing joint tenancies when one party left without notifying the Council. These updates also captured subsidiary earners who were not previously disclosed, leading to an increase in rent. iHouse is up-to-date and the total estimated annual additional revenue based on the households reviewed is €3,557,174.

Summary of Social Housing Assessments 2024

There has been a review of 141 approved housing applicants under the Summary Social Housing Assessment (SSHA) 2024. Letters have issued to these applicants, and it is essential that they engage to update or review their applications.

Regeneration

Moyne Latin School Heritage Centre

Moyne Latin School Heritage Centre was officially opened by former Longford County Council Leas Cathaoirleach Cllr Garry Murtagh. This new visitor experience tells the history of the role of Moyne in the development of education in the region and provides tourism and employment opportunities.

Moyne Latin School Heritage Centre was supported by Longford County Council and the

Department of Rural and Community Development under their Town and Village Renewal Scheme 2021.



Camlin Quarter Regeneration Project

Part 8 has issued in relation to the upgrade of the Mall Outdoor Facilities Upgrade. Closing date for submissions was Wednesday, 5 June.

Mall Complex: Changing Room Upgrade and Storeroom Extension

The changing room upgrade work is practically completed on the changing room upgrade, installation of new lockers and shower cubicles are outstanding.

For the storeroom extension, six quotations from local builders were sought, however, no responses were received. This work will now be procured on eTenders – open procedure.

Ballymahon Pobal Le Cheile

For the Ballymahon Pobal Le Cheile project, Rural Regeneration and Development Fund 2021 Part 8 planning was issued. The date for submissions closed on 13 May. This planning submission is currently on hold.

North Longford Rebel Trail Phase 2: Monaduff to Ballinamuck

North Longford Rebel Trail Phase 2: Monaduff to Ballinamuck works are ongoing and approximately 40% complete. Expected completion in September 2024. This is funded under the Outdoor Recreation Infrastructure Scheme (ORIS) Measure Three 2022

Regeneration

Active Travel

R198 Battery Road Pedestrian and cycle scheme

The footpath on the outbound side of the R198 Battery Road was reopened to the public from the entrance to St Albans up to the Lisbrack road junction. This section comprises a new concrete footpath with new cycle track running alongside. The finished red surfacing was applied to this cycle track and new decorative public lighting poles installed. The outbound carriageway lane has also been reconstructed along this section with the final surface course yet to be applied and traffic is now shifted onto this side.

Works have moved over to the inbound side of the Battery Road again working between Lisbrack road junction and Saint Albans. Installation of services and drainage are ongoing. ESB underground ducting network has been completed and the removal of the overhead network and poles was carried out. This has allowed for the construction of the separator kerb and carriageway kerb to be laid on the first 350m section.

When complete this Pathfinder sub project will deliver over 1.2 km of new footpath and cycle track along this key arterial route to Longford Town. Works will include the signalling of the Lisbrack road junction, carriageway and junction tightening along the route and the undergrounding of overhead services, public lighting upgrades and road reconstruction.

Active Travel Schemes in Granard

Two Active Travel schemes in Granard town had Part VIII planning were approved. The first of these will see a new footpath link along the R194 Longford Road Granard to link from Ard Scoil Padraig as far as the old Ulster Bank building. This scheme will include a new pedestrian crossing on the R194 along the route and involve carriageway narrowing and junction tightening works.

The second scheme will tie in directly to the scheme above and will see the construction of a footpath link from Market Street to Barrack Lane. Detailed design works and site surveys are ongoing for both schemes. Survey information had been obtained and the consultant is now progressing to detailed design and the preparation of a tender package.

Pencil Bollards at Entrance to Sacred Heart National School Granard

Enhancement works at the entrance to Sacred Heart National School Granard have been completed. Works included installation of 32 pencil bollards, pier removal with carpark entrance widening, kerbing, and surfacing.

These measures have sought to regularise parking and turning movements and to provide a more clearly defined and safer uncongested route for pedestrians on route to school.

Regeneration

Town Centre First

URBACT UR Impact

As part of URBACT UR Impact, URBACT Local Group (ULG) meetings took place in May and June. These meetings included discussions on opportunities and challenges related to the project. They also included discussions on the development of testing actions for implementation later in the year to test how the ULG will ensure the project has a positive social impact on the wider community.

Longford Town Centre First Strategy

Longford Town Centre First Strategy was launched in May with the Town Team and representatives of the national Town Centre First Office. The strategy sets out a vision for the development of the town centre through the delivery of nine transformational projects.



Ballymahon Town Centre First

There was a Town Team and ULG meeting held in May and June looking at place analysis. A public consultation event was also held in May. Several challenges and opportunities were

highlighted. This will inform the development of the plan. Data gathering continues regarding the current situation in Ballymahon.

Derelict Sites

There are currently 26 properties on the Derelict Sites Register. Work is progressing on including a further three properties on the Register. Engagement is ongoing with landowners to remedy their properties to get them taken off the Register. The Derelict Sites Levy will be applied from January 2025 on properties remaining on the register.

Granard Destination Town

For the Granard Destination Town project under the Rural Regeneration and Development Fund 2021, tenders were sought for the procurement of project management and design consultancy services with specific skills in urban design and public realm improvement projects. This is for the Granard town centre public realm and car park. Five tenders were received and have been assessed. The project is now awaiting Department of Rural and Community Development approval to appoint successful consultant.

Outdoor Recreation Infrastructure Scheme and Town and Village Renewal 2023

Applications have been submitted under ORIS and Town and Village Renewal for 2023.

Six ORIS 2023 Measure 1 projects have been approved for €180,000 funding.

Regeneration

ORIS 2023 Measure 2 applications approved are Granard Lights and Additional Walkway, Moyne Amphitheatre, and Legga Carpark

Two Town and Village Renewal 2023 applications with funding up to €250k have been approved. They are a Ballinalee playground and Edgeworthstown Mahon Building.

Roads

National Road Schemes

The N4 Newtownforbes to Clooniher (4km) scheme has been tendered. The contractor appointment will be approved by Transport Infrastructure Ireland (TII).

The N63 Gowlan (1.2km) scheme is awaiting TII approval to tender.

The N55 Edgeworthstown North (1.8km) scheme is at the design stage.

It is hoped to soon start pavement repair works on the N55 Fowlards Bridge.

TII have provided additional funding for the following schemes (with funding amount in brackets):

- N5 Aughareagh (€32,000)
- N55 Rathmore Patch Repair (€50,000)
- N55 Creevagh Beg Patch Repair at Cluain Rí (€50,000)
- N4 Kilsallagh Patch Repair at county boundary (€50,000)
- N4 Newtownforbes Drainage (€6,000)
- N55 Granard Drainage (€7,000)

An additional €50,000 in Defects Allocation funding was successfully applied for for the N55 Athlone Road, Ballymahon.

The following resurfacing schemes are currently at tender stage:

- N55 Edgeworthstown Level Crossing
- N63 New Street
- N55 Carrickboy

The preliminary design is complete on the R392 Abbeyshrule Road junction. Once the design is fully complete, the specific improvement scheme contract will be tendered.



Municipal District Works

Road maintenance works continued in each municipal district (MD). These works include footpath repairs, drainage, and pothole repairs.

Restoration improvement and restoration maintenance works on regional and local roads started in each MD. These works will continue throughout the summer.

Bridge inspections continue in each MD.

Bridge works are ongoing. These works have been completed on the Tawnagh/Aghadowry bridge. Works will start on the bridge at Leggagh (Dromard GAA). Other bridge works scheduled for this year include Ballagh/Curraghboy,

Roads

Crott/Smear, Drummeel/Breaghy and Liscahill/Gneeve.

Public lighting upgrades continue with larger scale upgrade works at (upgrade cost in brackets):

- Pauric Column Heights (€51,000)
- McEoin Park (phase one), includes resolving direct feed issues (€45,000)
- Clonbalt Woods, includes resolving safety and electrical issues (€25,000)

Road Safety

The Road Safety Working Together Group met to discuss actions within the current Road Safety Plan. The Road Safety Working Together Group is made up of members from Longford County Council, An Garda Síochána, Transport Infrastructure Ireland (TII), and the Road Safety Authority (RSA). This meeting was also an opportunity to for County

Longford road safety updates from all members. This meeting was followed by a meeting of the Collision Prevention Group.

As part of Bike Week in May, all primary schools were invited to take part in a road and bike safety poster competition. This was an opportunity for students to think more about road safety, how to keep themselves safe, and to become familiar with the RSA's Rules for Safe Cycling.

Hundreds of students attended a Longford Microsoft Dream Space Showcase in Edgeworthstown Community Centre. The event included road safety information table with interactive alcohol and drug impairment goggles which showed how vision can be impaired and the effects of this on driving. There was also information on the importance of wearing safety items for pedestrians and cyclists. There was also the promotion of the Keep the Race in its Place, an RSA and Motorsport Ireland safety campaign.



Roads

Climate Adaption Strategy for Regional and Local Roads

The Department of Transport's Climate Adaption Strategy for Regional and Local Roads has been adopted by Longford County Council's Roads section. This strategy has the aim of improving the resilience of regional and local roads against the impacts of climate change.

The strategy identifies actions required to improve climate resilience including updating existing guidance documents, producing vulnerability mapping, identify critical infrastructure routes, and works prioritisation methodology.

Environment

Longford Microsoft Dream Space Showcase

Longford Microsoft Dream Space Showcase took place in May. At the event, the Council's Climate Action and Environment team had an interactive and engaging exhibition stand to promote environmental awareness among students. This included biodiversity awareness. Awareness videos were shown, followed by an interactive quiz for up to four players playing for prizes. Feedback was positive from both students and teachers.



Multi Annual Rural Water Programme 2024-2026

A Multi Annual Rural Water Programme 2024-2026 funding application was submitted to the Department of Housing, Local Government and Heritage on behalf of Clonmore/Kilmore and Derryohill Group Water Schemes.

The Environment team supported several other community connections and Group Water Schemes in their application. Unfortunately, due to criteria requiring a minimum of 25 houses for community connection applications, a restriction in grants of €15,000 per house, and criteria in relation to the development of options reports, it was not possible to progress applications for a further five schemes.

Longford County Council TidyTowns engagement event

Longford County Council's first TidyTowns engagement event was held in Edgeworthstown Library in April, with 16 local TidyTowns groups in attendance. Guest speaker Ann O'Leary gave an informative presentation as she shared her experience as a TidyTowns adjudicator for the past 43 years. The Biodiversity Officer and Environmental Awareness Officer also gave presentation on the day.



Environment

Septic Tank Inspections

In May, the Environmental Protection Agency (EPA) issued their Domestic Waste Water Treatment System Inspections 2023 report which is a review of its National Inspection Plan. Longford County Council ranked nine out of 31 local authorities for the percentage of waste water treatment systems fixed after any failing inspection since 2013.

The average national inspection failure rate is 45%. This compares with 63% in County Longford last year. The EPA requires a minimum number of septic tank inspections annually. Longford County Council exceeded its allocated number of inspections in 2023, inspecting 10 sites.

It is now easier for to access grants and remediate waste water treatment systems that fail inspection. Since the start of 2024, the requirement for septic tanks to be on the Protect Our Water Register was removed and the maximum grant available to householders was increased to €12,000.

Granardkille Cemetery Boundary Wall Remediation Works

Essential maintenance works took place at various cemeteries throughout the county. Most notably this includes the remediation of the boundary wall at Granardkille Cemetery.

Adverse weather conditions and an original design defect had over time compromised the structural integrity of the stone face boundary wall. The cost of the wall remediation was

around €25,000. It was considered the most appropriate solution, by sustaining the longevity of the wall without having to ultimately remove and replace a failed structure.



Waste Enforcement Regional Lead Authorities (WERLA)

In May, the Environment team hosted the Waste Enforcement Regional Lead Authorities (WERLA) Operations meeting for 2024 Q2. Longford County Council is a member of the Eastern Midlands WERLA which is one of three regional groups. WERLA work with local authorities in setting priorities and ensuring consistency of enforcement of waste legislation, while allowing local authorities to be the first responders on the ground.



Environment

Anti-Dumping Initiative Funding

Illegal dumping remains a priority for the Council. The Environment team successfully submitted for funding of €70,800 under the Anti-Dumping Initiative for several projects, including:

- Installation of CCTV at illegal dumping blackspots
- Transform McEoin Park waste ground into an edible garden amenity area
- Feraghfad and Keenagh illegal dumping clean ups
- Camlin River protection fencing
- Provision of accessible bring banks
- Bulky goods and mattress collections
- Your Country, Your Waste anti-dumping campaign

Dangerous Structure

Property owners are legally required to ensure their property does not contain any dangerous structures. If it does, they must take steps to remedy the situation or they may face prosecution. The Council is empowered to deal with dangerous structures and can require an owner to carry out works to prevent the structure from being dangerous.

In May, a Notice under Section 3 of the Local Government (Sanitary Services) Act, 1964 (as amended) was issued to the owner of a premise, requiring the demolition of the structure in whole or in part to prevent the structure from being a dangerous structure. The owner demolished the structure in part and

secured the site within 14 days of serving the notice.

Following the demolition works the local community gave the area a much-needed facelift, painting the entirety of the hoarding ahead of the National Famine Commemoration event. This is an excellent example for collaboration and cooperation between the council, property owner and local community, to make a dangerous structure safe and improve the visual amenity of an area.

Large Goods Collection

A one-day large goods collection was held to assist the public to dispose of large goods correctly. Large goods includes beds, mattresses, furniture, carpets, toys, and household scrap metal.



Environment

Biodiversity

Local Biodiversity Action Fund

County Longford biodiversity projects have been approved for €117,647 funding (including €17,647 match funding) by the National Parks and Wildlife Service (NPWS) from the Local Biodiversity Action Fund.

Biodiversity Action Plan

A list of plant and animal species in County Longford using the National Biodiversity Data Centre database has been compiled. An inventory of amenity areas and areas of biodiversity interest is being developed. This work is part of the preparation for a Biodiversity Action Plan. Stakeholder engagement on the preparation of the Biodiversity Action Plan is also ongoing.

Biodiversity Working Group

The first meeting of the Biodiversity Working Group took place on the 15 May with Longford County Council, NPWS, Teagasc, Coillte, Bord na Móna, LAWPRO, and Hedgerows Ireland all represented on the working group.

Biodiversity Week

Biodiversity Week took place in May with several events in County Longford. This included talks given by the Biodiversity Officer at each of library in the county. A talk was also held in conjunction with the Office Public Work and Longford County Council at Corlea Trackway. A hedgerow walk was given by Richard Markham in the Mall. A Barn Owl talk

was given by BirdWatch Ireland in the Longford Library headquarters.

Urban Forest Project

Longford County Council and the Longford Community Resources clg Social Inclusion Community Activation Programme obtained over 300 trees from Future Forests, Cork, Uplift and Coillte.

In April, a tree planting event was organised where a mixture of native oak, alder, birch, rowan and Scots pine trees were planted. For this members of Roma, asylum seeker and Ukrainian communities and residents came together to celebrate the cultural diversity with the symbolic planting of roots.

Brendan Farrell from Ardagh Village Landscaping was on hand to help with the planting and layout of the new urban forest. The trees were laid out to resemble how a natural forest would form.



An Taisce National Spring Clean

In April, An Taisce held their annual National Spring Clean initiative. Sixteen Longford groups participated by organising clean-ups of their local towns and villages to tackle litter, improve their environment and protect biodiversity.

Environment

This local effort fed into the overall National Spring Clean. This is the 25th year of the campaign, which has seen the removal of an estimated 47,500 tonnes of litter from the environment.

Climate Action

Longford County Council's Climate Action Plan

Longford County Council Climate Action Plan has been launched. The Plan can be viewed on the Council's website under the Environment section.

The Community Climate Action Fund

The Community Climate Action Fund had 20 applications for funding of €680,000. The evaluation committee met in April and 14 projects from Strand 1 and one project from Strand 1a were recommended to the Department of Environment, Climate and Communications for funding of €328,000. It is anticipated that it will take 8-12 weeks for final approval.

Electric Vehicle Chargers

The 50kw electric vehicle (EV) chargers in Ballymahon, including its street carpark, are now operational. Chargers at Lanesborough, and Longford Centre are due to be commissioned shortly. Granard is contingent on progress with the construction of the carpark behind the Garda barracks.

Tenders for the Zero Emission Vehicles Ireland (ZEV) strategy have been received by Offaly County Council. Tender assessment involving the five participating counties is currently being organised.

Fire Services

Call Outs

All stations remained fully operational. There were 57 callouts up in May and June (up to 26 June). Of these callouts, three units of Longford fire brigade attended a large industrial fire in Ballymahon on Wednesday, 26 June. The building suffered substantial damage.

Training

A one-day breathing apparatus refresher course was completed by 40 firefighters. This was held in Tullamore. Two instructors completed a three-day compressed air foam refresher training course in Longford Town. This was a national course held in Longford. One recruit fire fighter completed a one-week compartment fire behaviour course in Carlow.

All fire service employees are to receive climate awareness training which is being rolled out nationally.

Health and Safety

There are no injuries to report.

Fire Certificates and Licences

- Five Fire Safety Certificates were processed.
- Two Circuit Court and three District Court licence were processed.

Fire Safety

Edgeworthstown fire brigade did a chip pan fire safety display at Longford Dream Space Showcase.



Recruitment

Eight more people have completed the pre-selection process for the position of Firefighter in various Stations.

The recruitment process is still open as we will still have vacancies in Lanesborough, Granard and Ballymahon.

Equipment

A second-hand Jeep has been purchased for Granard fire brigade. This is to be used at road traffic incidents and replaces an obsolete Jeep.

The National Directorate for Fire and Emergency Management has sanctioned capital approval of €57,000 for the purchase of eight new thermal imaging cameras and a decontamination washing machine for breathing apparatus sets.

Training and Operations

Volunteers completed missing person search responder certification.

Manual handling instructors completed the first part of their upskilling course.

Training at a drill night with Longford Fire Station fire fighters took place.

Longford Civil Defence purchased Mapyx mapping software to assist with support to the primary response agencies. Two volunteers received training to operate this software.

Longford Civil Defence assisted An Garda Síochána with a missing person search. Longford Civil Defence were supported with this search by Roscommon, Offaly, Mayo, Dublin and Meath Civil Defence units.

An obsolete ambulance was donated to a charity organisation, where it will be sent to Ukraine.
