

# Library, Heritage and Archives

## Longford County Library Service

While closed, staff continue to provide services by telephone, online, collection and delivery. Longford Civil Defence have continued to assist with book deliveries. Online spring events for adults, especially aimed at those isolated or living alone, are being delivered through the Community Forum Network, social media and local media. In partnership with 39 local primary schools, events promoting creativity in education are being delivered weekly.

#### Edgeworthstown Library

The site is closed due to Level 5 restrictions.

### Longford Age Friendly

Longford Age Friendly's Keep Well weekly events are helping older people stay connected, eat well, mind their mood, switch off and be creative. Programmes with Shannonside Radio on the these topices are also being delivered. The Basic Digital Skills for Older People Course is also online, with eight adult learners.

### Creative Ireland

The annual open call for grant application has been issued, inviting submissions for innovative creative projects. Closing date is 1 March. All programmes for Q1 will take place online, with the first, a programme for secondary schools, starting 8 February.

#### **Clonfin Centenary Commemoration**

A full programme of events throughout the year for Longford Decade of Centenaries, starting with the Commemoration of the Clonfin Ambush, 2 February 1921. Taking place online on 7 February, view on Longford County Library, Heritage and Archives Services YouTube or Facebook pages.



#### Heritage Programme

The Heritage Office is administering the DHLGH Built Heritage Grants, the Built Heritage Investment Scheme 2021 and Historic Structures Fund 2021. Closing date is 22 February. On 13 January, the Heritage Office hosted a webinar on these grants, as well as the GLAS Traditional Farm Buildings Scheme, with testimonials from previous participants.





# Regeneration

Town & Village Renewal Scheme

€403,388 in funding under the Town & Village Renewal Scheme was announced, assisting Longford towns and villages, to respond to the challenges of COVID-19, to aid economic recovery and to make them safer places to live and work. Projects to be implemented include the development of remote working facilities, walking and cycling tracks to support recreational amenities and public-realm work on footpaths, lighting and signage to enhance town centre streetscapes. The Regeneration Team, along with community groups and town teams, look forward to working on these projects in 2021.



#### Aughnacliffe Walkway

The construction of a footpath to link residential and services areas in Aughnacliffe is underway. The walkway will connect to the Waterfall Trail, a trail developed by the local community, as well as connecting to Lebeen Park and the local playground. This will help to improve economic activity and tourism in the village.



## Edgeworthstown Library & Public Realm

Work had progressed well on Edgeworthstown Library, with the structural timbers installed prior to Level 5 Restrictions. The Library is now watertight, due to an accelerated effort in advance of current COVID-19 Restrictions. Work on the car park and the plaza have progressed. Undergrounding of services are complete and street lighting is operational along Edgeworthstown's Main Street. This project will be completed later in 2021.

#### **ORIS Funding Announcement**

€122,745 funding has been announced by the Department of Rural and Community Development, to be utilised for walkway trails, signage and footfall counters to quantify the number of users and impact of investment in trails. These projects will be progressed in 2021 by the Regeneration Team throughout Longford.

# Housing

### Estate Management

The Estate Management Unit have acquired an Estate Management Van for high visibility, patrolling Longford County Council Housing Estates.

This positive approach not only contributes to increasing tenant awareness of our presence, but also helps prevent crime, promotes community engagement and offers a sense of reassurance.

A preventative method of dealing with Estate Management issues, this is an essential element of Longford County Councils Anti-Social Behaviour Strategy.



#### Housing Projects

During 2020, 45 new houses were constructed as part of the SHIP programme, with a further 25 new houses' construction commenced on site, consisting of both Direct Build and Turnkeys.

32 aditional houses were also aquired, with upgrading and pre-letting works carried out before handing the keys over to tenants.

Longford County Council also supported two AHBs to secure funding to acquire and upgrade 6 properties. These properties will provide accommodation and tenancy support services to allow independent living for the most vulnerable in the community.

Under new regulations issued on the 7 January 2021 and public health restrictions affecting the construction industry, work has stopped on the following projects:

- 6 units at Rose Cottage, Ballinalee
- 1 unit at Fairgreen View, Longford

Work is continuing on several essential designated status projects including:

- 1 unit at Cloonahard
- 8 units at Alder Field, Farnagh
- 5 units at Cartrons Kenagh
- 9 units at Sli Corglass, Legga

# Planning

## Planning Applications and Enforcement

Statutory requirements maintained, including:

- Assisting in the implementation of the Housing and Regeneration Programme

### Development Plan

Statutory requirements maintained, including:

- Development Plan Review ongoing, setting out the template for county development up to 2027
- Second Phase Public Consultation on the Draft Plan is now complete
- Preparation of Chief Executives Report on the submissions are being prepared for presentation to members in March 2021
- Revised Plan is to be presented to members 21 June 2021
- Draft Plan is to be complete November 2021 for members adoption
- All aspect of Longford's future development potential has been analysed, with strategies, policies and GIS mapping developed
- Improving Longford citizens' wellbeing, climate change stratgies and enhancement of biodiversity, as well as clear actions are incorporated into the Plan

# Roads

#### **Essential Maintenance Works**

Due to Level 5 Restrictions, Roads focused on essential maintenance works on public roads to maintain the operational capacity and safety of the road network. Essential maintenance works included drainage, pothole repair, winter maintenance and emergency call outs.

### N4 Mullingar to Longford (Roosky)

The Second Public Consultation on the Route Corridor Options for the N4 Mullingar to Longford (Roosky) commenced on 29 January. Submissions can be made up to 19 March 2021.

#### Active Travel Measures Scheme

Preliminary Application for Active Travel Measures Schemes was submitted to the NTA.

#### Roadworks Programme for 2021

In partnership with Longford MDs, Roads are delivering the Roadworks Programme for 2021, including the delivery of the following grant-funded projects:

- Restoration Improvement Schemes
- Restoration Maintenance Schemes
- Bridge Rehabilitation Schemes
- Discretionary Grant Schemes
- Safety Improvement Schemes
- Specific Improvement Schemes
- Local Improvement Schemes
- Community Involvement Schemes

Preparation of the Programme is ongoing with Department of Transport allocations to Local Authorities, due to be announced in February.

## Water

## Water Service Continuity

Water Services are essential and a priority, continuing to provide services during COVID-19, including ensuring the continued provision of drinking water, particularly in areas with headroom or supply issues.

#### Find & Fix Programme

Longford County Council and Irish Water is continuing the Find & Fix Programme throughout Longford. This national project aims to deliver major water leakage savings.



Find & Fix Crews are currently operating in:

- Granard DMA (second sweep)
- Rathcline Road DMA
- Lanesborough Rural DMA

Utilising the data obtained from the Leakage Management System (LMS), Longford County Council's Find & Fix Team investigated, found and repaired major leaks. An example of this from this month is within the Rathcline Road area of Lanesborough, achieving a saving of 8 cubic meters of water per hour (192,000 litres per day).

## Capital Network Schemes

Irish Water, in partnership with Longford County Council, are currently progressing the installation of approximately 1400m of new watermain to replace the existing old problematic watermain at Ballymakeegan, as well as the installation of a new watermain and connections to Templemichael and Bannon Terrace, Longford. Both schemes will improve the water network and increase the security of supply to these areas and are due to be completed in early 2021.

## Early Contractor Involvement (ECI) Water Programme

Irish Water, in consultation with Longford County Council, is continuing the ECI Programme. This national programme aimed at carrying out improvement works at water treatment plants, will ensure the continued delivery of safe drinking water.

Theprogramme is currently at final construction stage at the Lough Kinale, Granard and Lough Gowna, Smear, water treatment plants. Works are due to commence in February at the Lough Forbes, Longford, water treatment plant.

Longford County Council Water Services continue to work closely with the appointed contractor to ensure the continued safe operation of the water treatment plants during the construction phase.
