### **Community Development**

Local Community Development Committee (LCDC) A meeting of the LCDC took place on 8 June 2021.

#### LEADER

Three LEADER projects were approved for funding of over €122,000 at the LCDC meeting.

#### Community Enhancement Programme 2021

# Community & Enterprise

### Library Heritage & Archives

#### Edgeworthstown Library

The new Edgeworthstown Community Library took a step closer towards completion with the scaffolding coming down from the front of the building on 18 June. Edgeworthstown's community, sporting, education and business groups were invited to present an item that best represented their organization to go into a time capsule to be buried in the plaza at the front of the building. Longford County Council Cathaoirleach Cllr Paul Ross officiated the event, along with Ballymahon Municipal District Cathaoirleach Cllr Colm Murray.

#### Longford County Library Service

Since reopening on 10 May, a steady flow of customers have come into all brand libraries with a particular demand for printing and copying services and block loans from local schools. The Summer Stars Reading programme aiming to encourage children to join the library and read for pleasure during the summer holidays has been launched. The programme was shared to all Longford primary schools prior to the summer holidays.

#### Longford Age Friendly

New Healthy Homes Coordinator for Longford is working with relevant service providers raising awareness of the supports available to ensure older people can live in their homes for as long as they wish. The Healthy Homes Coordinator also met with Longford Older Persons Council at a meeting held in Library HQ, the first hybrid (online and in-person) meeting of the group since COVID-19 started. Older people not confident with online meetings attended socially-distanced in person, while others attended online.

#### Creative Ireland

Cruinniú na nÓg 2021 festival took place on 12 June. Ireland's national day of free creativity for children and young people. Several live events took place outdoors, in addition to a full programme of online events. The day was launched by Cathaoirleach ClIr Paul Ross in Ballymahon's playground as the new Playground Passport: A Family Guide to Longford's Playgrounds. was launched. ClIr. Peggy Nolan launched a new childrens' book by Longford photographer Shelley Corcoran in the Mall in Longford.

#### Decade of Commemorations

The Schools Information Pack on Ireland and Longford in Times of War and Revolution, 1914-23 launched in June. Packs will be sent to every school in Longford in September, with digital versions sent to primary schools.

#### Heritage Programme

Work continues on the County Heritage Plan 2021 projects. The Wetlands Field Survey was tendered, with Wetland Surveys Ireland successful. Their focus will be on the Camlin River.

The conservation report for the plaster Oliver Goldsmith statue at Pallas went to tender, with three valid submissions currently being assessed.

Family and school-friendly information and activity leaflets for Moyne Latin School Visitor Centre near completion. The design to be tendered soon, with the aim of full completion for Heritage Week in August. Heritage Week preperations have begun.

Work commenced on several built heritage conservation grants projects. Applications to the Community Monuments Fund 2021, for the tower house at Abbeyshrule Abbey and Ballyduffy Castle were successful, with the department issusing the required Ministerial Consent for the Abbeyshrule repair.

### Local Sports Partnership

Summer Water Sports Programmes Longford Sports Partnership summer water sports programmes started this month. Our Primary Schools' Kayak and Paddle Board Taster Sessions ran throughout June with 20 schools and 400 students participating.

Adults also got onto the water with our Women on the Water and Men on the Moving Water kayaking programmes. Abbeyshrule Canoe Club also began their leadership development programmes.

Our Beach to Buoy: Introduction to Open Water Swimming began in Annagh Lake with 27 participants getting a taste for the open water swimming for the first time. Overall, 517 people got active in June through water sports with Longford Sports Partnership.



Primary Schools Sports Hall Athletics Our very successful six-week programme of sports hall athletics concluded at the end of June. Schools across Longford got involved with over a 1000 students taking part, learning new skills and having fun. This programme was supported by Healthy Ireland.



#### Cycling Programme

Our Women on Wheel cycling programme on the Royal Canal Greenway from Clondra started in June. Aiming to encourage more women into cycling, it teaches the skills needed to be a confident, safe cyclist, as well as encouraging greater use of the Royal Canal Greenway for cycling and commuting. The programme will run over 12 weeks with 12 participants.

#### Walking with Poles

Our two Nordic and Activator Pole Walking Programmes started in June with older adults in the Mall in Longford and Leebeen Park in Aughnacliffe. 40 participants from the Arthritis Association Longford Branch and Rath Mhuire and Dolman Centre active age group are enjoying this programme which runs for six weeks.



### Regeneration

#### Moydow Community Centre and Broadband Connection Point (BCP)

Moydow Community Centre fitout and Broadband Connection Point launch took place on 17 June. Broadband Officer Christine Collins presided over the Launch, which had speakers representing Moydow community groups, Longford County Council and the Elected Members. Longford County Council Cathaoirleach for 2020-2021 Cllr Paul Ross, Cllr Colm Murray, Cllr Mick Cahill and John McKeon and members of the Regeneration team attended.



This new facility has smart screens, multi-functional printer, desks and chairs and all necessary electrical equipment, as well as a dedicated remote working room. Adding value to Moydow, this facility is especially important now and into the future as remote working becomes more mainstream.

#### Legga Footpath

Construction of a footpath linking St. Mary's Church and Legga Cemetery was completed in recent weeks. The 300m footpath links key services within the village and provides a safe walking area between the village, St Mary's Church and Legga Cemetery, as well as enhancing the village centre visually.

#### Funding Applications

Shortlisting of applications of suitable projects under the Town and Village Renewal Scheme 2021 took place with eight applications to be submitted to the Department of Rural and Community Development. The Regeneration Team is currently working with these community groups to finalise and submit these applications by the deadline of 16 July. Seven funding applications have also been prepared for submission under Measure One of the Outdoor Recreation Infrastructural Scheme. (ORIS)

#### Ballinalee Forest Walk

Seating and solar LED lanterns along the walkway from the Shantobar residential development in Ballinalee to Sean Connolly GAA Club and the Acres Pitch and Putt Club has now been installed. This walkway was completed earlier this year. The newlyinstalled public lighting and seating will greatly enhance the facility, ensuring its use year-round. The walkway itself provides an important link between the residential areas and local amenities.

### Housing

#### Social Housing Scheme Openings

Minister of State for Local Government and Planning, Peter Burke visited Longford to officially open three new social housing developments. All three estates, Cartons in Kenagh, Charlotte's Row in Edgeworthstown and Rath Reagh in Legan, were delivered in late 2020 under the Social Housing Capital Investment Programme (SHCIP) and are currently accommodating 36 adults and 63 children. Charlotte's Row consists of five twobedroom bungalows accommodating five families. The turnkey development at Cartrons, Kenagh also accommodates five families and comprises of five four-bedroom two-storey houses. Rath Reagh in Legan consists of a mix of three- and four-bedroom houses.

#### Housing Capital Programme

#### Choice Based Letting

Two properties under the Choice Based Lettings (CBL) Scheme were recently advertised two properties to let. Those wishing to bid on a property advertised under this scheme must have an open and approved Housing Application. Households that wish to be considered in the allocation of a bid dwelling must, within three weeks of the publication of the notice, apply in writing, and supply any supporting information specified in the notice. Eight expressions of interest have been received for the properties at 64 and 65 Ardnacassa Avenue, Longford. CBL can be used for the allocation of social housing and is designed to offer more choice and involvement for applicant households in selecting a new home.

# Strategic Infastructure & Climate Action

### Roads

Roadworks Scheme



Summer months are a busy period with roadworks taking place throughout Longford. Construction works on the Roadworks programme are ongoing in each Municipal District, with the focus on Restoration Improvement and Restoration Maintenance Works.

Work on the Newtownforbes Pavement Resurfacing Scheme commenced in early May and continues for the next four months. Roadstone Ltd are carrying out this footpath replacement works and drainage works, with road resurfacing works to follow.

#### N4 Mullingar to Longford (Roosky)

The N4 Mullingar to Longford (Roosky) Scheme is currently at Phase 2: Options Selection. The Route Corridor Options put on display during the recent public consultation will now be assessed in accordance with Transport Infrastructure Ireland (TII) guidelines in order to determine the Emerging Preferred Route Corridor (EPRC). This involves detailed assessment of the options under the following criteria: Economy, Safety, Environment, Accessibility and Social Inclusion, Integration and Physical Activity.

Feedback received as part of the second public consultation on the route corridor options are currently being reviewed by the project team and will be taken into account as part of this option selection process. It is envisaged that the EPRC will be identified in Quarter 4 2021.

#### N55 Athlone to Ballymahon Project

Westmeath County Council in partnership with Longford County Council and in association with Transport Infrastructure Ireland (TII) held a public consultation in relation to the Emerging Preferred Route Corridor for the N55 Athlone to Ballymahon scheme in June 2019.

Submissions received as part of this public consultation were reviewed. As a result of this review, two possible modifications to the Emerging Preferred Route Corridor are now being investigated and assessed by the design team in order to finalise the Preferred Route Corridor in Mid-2021.

# Strategic Infastructure & Climate Action

### Water Services

#### Find & Fix Programme

Longford County Council and Irish Water commenced the Find & Fix programme in Longford in 2019 with the aim of reducing water leakage in the network. Drinking water is a valuable resource and its production requires high energy use, therefore, water conservation plays a major role Irish Water and Local Authorities' mitigation and adaption to climate change.

Significant progress has been made with reduction of water leakage through the implementation of this programme. The Longford County Council Find & Fix team recently completed a campaign in the Ballymakeegan area of Longford achieving savings of approximately 78,000 litres of drinking water per day. The team is currently operating in the Legan and Moydow district meter areas (DMAs). The Find & Fix team also recently installed a new DMA bulk meter at Lisduff, Longford which will assist with water usage monitoring in the area.

#### Capital Network Schemes

Irish Water in partnership with Longford County Council, is currently completing the final connections to the newly-installed watermain at Templemichael and Bannon Terrace, Longford. Both schemes will improve the water quality and increase the security of supply to these areas.

The Water Services Capital section are currently liaising with Irish Water to prioritise watermain infrastructure improvement schemes, to be completed in 2021.

#### Water Conservation

Irish Water, in partnership with Longford County Council, is urging the public to conserve water to ensure a consistent supply over the summer months. With current public health advice urging people to holiday at home, it is predicted there will be an increase in domestic and commercial demand. Customers are, therefore, asked to take some simple steps to save water in their homes, their businesses and on their farms. Saving water should be done year-round, not only when supplies are under pressure due to drought conditions and seasonal increases in demand.

Irish Water and Longford County Council Water Services are continually working to protect the supply and demand balance. This means there is a need to ensure the supply of more treated drinking water than is required for use. This can be managed by saving water; losing less by repairing leaks; and supplying smarter by ensuring that all of our plants are working optimally. Statutory Requirements maintained:

# Strategic Infastructure & Climate Action

### Environment

Protect our Water from Pesticides Longford County Council Environment Section is part of a multiagency group consisting of representatives from the Department of Agriculture, Teagasc, Irish Water and Leitrim and Roscommon County Councils who are focused on the challenges presented by pesticides in lakes and rivers. Ongoing monitoring for pesticides continues to show widespread issues in the Shannon Lough Rynn catchment. Poor practice in the use of pesticides to control weeds, by landowners and households is considered a significant contributor to this problem. A reduction in the use of pesticides has major benefits for water quality and biodiversity. Steps are being taken by Longford County Council to raise public awareness of this issue including via print, radio and social media during the summer months.

#### Littering from Outdoor Dining

During the month of June, Longford County Council ran a series of ads on iRadio in relation to outdoor dining and littering targeting a younger audience. A radio interview was also held to highlight the issue.

#### Longford Leader – Green Schools

Adverts were placed in the Longford Leader in June for the school supplement, the first thanking schools for their hard work in Green Schools and the second for keeping outdoor spaces clean and tidy after visiting them.

### Veterinary Services

Meat premises were visited in June to assess and advise on the current requirement for Veterinary Export Health Certificates for meat exported into or through Great Britain from 1 October.

### Fire Services

#### Operations

- Total callouts in June: 25
- All stations remained fully operational

#### Health and Safety

No injuries to report, but two near miss incidents have been recorded and are being followed up on.

#### Training

- Training courses are being rescheduled on an ongoing basis due to COVID-19
- Fortnightly drills are back and up and running
- All fire-fighters did compartment fire behaviour training in Ballinrobe
- Longford Town Station Officer instructed on a national station trainer course for the National Directorate for Fire and Emergency Management (NDFEM)
- A further two fire officers completed officer command and control training in the Hydra Centre in Clonmel. Three fire officers completed this training in May.

#### Major Emergency Management

Regional Working Group meetings were held fortnightly by teleconference working on COVID-19 measures.

#### **Fire Prevention**

- Four Fire Safety Certificates processed in June
- Fire Service inspections and community fire safety activities continue on an appointment-only basis

#### Recruitment

We have five vacancies in three fire stations:

- Granard (2)
- Edgeworthstown (1)
- Lanesborough (2)

The recruitment of one recently successful candidate is being processed.

## Civil Defence

**Duties & Taskings** 

- Volunteers provided medical cover at two Longford Town soccer matches, making up 36 volunteering hours
- Medical cover was also provided at one GAA match involving 18 volunteer hours

#### Training

- Manual Handling instructor recertification is underway for two volunteer instructors
- Community First Responder training took place for four new recruits
- Community First Responder course was provided to Longford Town FC underage coaches
- Training ongoing for new recruits
- One volunteer attended critical incident stress management webinar

#### Operations

- Attendance at the Community forum online meetings to provide an update and offer support for ongoing community response in Longford
- Volunteers remain on standby should they be required to assist in the vaccination centre
- Statutory inspections of equipment including vehicles and equipment

### **Climate Action Initiatives**

#### Tourism

Longford Tourism are developing their online advertising in order to be as environmentally friendly as possible.

#### Human Resources

- Climate Action Raising Awareness Training completed Grade V and analogous employees
- Climate action included in all recruitment competitions and contracts of employment

#### Regeneration

- Piloting of solar lighting on Ballinalee walkway to reduce energy usage
- Promotion of sustainable mobility through ongoing development of strategic walking and cycling corridors between tourism areas, towns and villages

#### Housing

- As part of the Midlands Retrofit Programme work is ongoing on the retrofitting of four Council estates in Ballinalee: Rivers Crescent, Camlin View, Cois na hAbhainn and Hill View
- Tender is also in progress for St Matthews Park, Ballymahon
- Survey works commenced on a further 46 local authority houses in the county
- Tenders are now being prepared under the National Energy Efficiency Programme for the retrofitting of 19 houses at Slí na Móna, Ballymahon

#### Roads

Longford County Council Roads Department has been allocated funding of approximately €250K from the Department of Transport for three road schemes in Longford for road adaption and resilience works. These have become necessary due to the effects of climate change. Works include road edge protection on the Ballagh-Drumlish Road (L1077), embankment stabilisation and verge construction on the R198 at Tawnagh and drainage on the R396 at Abbeylara to alleviate road flooding.

#### Planning

- The Development Plan review includes a specific chapter on climate change and each individual chapter ends with a climate change checklist
- Work is being prepared on active travel measures for Longford Town
- A new graduate has been recruited to Planning to develop climate actions for the county

#### **Fire Services**

In the past month the fire service has been called out to bog fires to prevent the release of more carbon.
